### Scoville Park Community Meeting #1

Location: Oak Park Public Library - Veteran's Room

Date: March 24, 2010

Time: 7pm

## **Minutes of Meeting**

Mr. Gary Balling, Executive Director of the Park District, made the introductions to the meeting.

Gary Balling welcomed the attendees and introduced Park District Commissioners, members of the Park District Citizen Committee and staff that were present. He provided a brief summary of the park planning process thus far noting that Scoville Park is the seventeenth of eighteen parks to go through the process. There have been six focus groups held already where the design team received initial input on the current conditions of the park and neighborhood from Village and Park District Staff and officials. Mr. Balling then confirmed the schedule for the process as follows:

Community Meeting #1 Wednesday, March 24<sup>th</sup>, 2010

Community Meeting #2 Wednesday, April 21<sup>st</sup>

Community Meeting #3 Thursday, May 11<sup>th</sup>

A 4<sup>th</sup> meeting would be held if necessary.

There will be a questionnaire posted on the Park District website starting on March 25<sup>th</sup> at 5PM and residents can also contact the Park District through telephone, emails, and mail.

\$725,000 has been set aside for the first phase of the project but there may be other phases of work as this is process is to produce a long term plan and coordinated vision for the park.

He then introduced the design team and handed the meeting over to John Mac Manus of Altamanu, Inc. Mr. Mac Manus presented a PowerPoint presentation and then requested comments.

#### **Summary of the Presentation**

Though the purpose of the meeting was to collect public input it was also desirable to give the attendees something to react too; therefore while giving a presentation on the park Mr. Mac Manus also informed the attendees of suggestions made at the Focus Group meetings.

Mr. Mac Manus provided brief summaries of; Scoville Park's many roles within the community, its geologic history and history prior to development, the surrounding urban context and its relationship to the park. He then addressed the history of the park.

#### History

There are many layers of history to the park and its surroundings. The Hemingway Museum is adjacent on Oak Park Ave.; Frank Lloyd Wright's Unity Temple is on Lake St., and the birthplace of Oak Park, through the story of the Kettlestrings, the Scoville family, Jensen, memorials such as the Percy Julian sculpture etc. is firmly sited in Scoville Park.

#### Jens Jensen's Plan 1913

In 1913 the Scoville house located on top of the hill was demolished, the land was transferred to the Park District, and noted landscape architect Jens Jensen began his design for the park. Mr. Mac Manus went through the plan in some detail and spoke about Jensen's design philosophy and the changes in American attitudes towards their own landscape.

Though the park is on the National Register of Historic Places there are differences between the park today and the original plan. The Peace Memorial was dedicated in the 1920s. There was a pond in the southwest corner and a wading pool in the northwest corner where the tot lot is today. Several of the paths have changed often taking on a less sensuous quality. Jensen avoided placing entries at the corners of the park and today's entries and plazas at the SE and SW have been added over time. There is a heritage oak on site and a plum that is not noted on Jensen's plan but is of significant age. Some groupings of flowering trees may be original but the arborist who investigated the site was not of that opinion.

Mr. Mac Manus provided a brief summary of Jensen's background and its effect on his design philosophy. He was a conservationist, environmentalist, and designer of parks. The forest preserves are a legacy of his advocacy. He was a major proponent of preserving the native Illinois landscape and the use of native plantings.

Mr. Mac Manus presented an overlay of the 1913 Jensen plan superimposed over an aerial of the park today and continued to discuss some of Jensen's design. Jensen disliked the straight line and straight path and referred to it as 'the tyranny of the straight line". Instead his path system had a very sinuous, organic feel which has since been straightened in several areas, particularly around the monument.





Jensen incorporated large expanses of shrubs and understory trees, especially around the perimeter of the park, which would be beautiful if reinstated into the park today but what would be the impact on the use of the park? Would this present a security concern and risk? Part of our task is to decide on how we might address Jensen's design and that maybe we could reinstate his design philosophy in the context of our times.

#### Virtual Walkthrough of the Park

Corner Plaza at Oak Park and Lake Street

Mr. Mac Manus continued his presentation with a walkthrough of the park in photographs starting at the corner of Lake St. and Oak Park Ave. The corner is probably the most important entry into the park. Is the present entry the one we would like? Is it a welcoming space? Moving into the park there's a strong desire line cutting across the meadow to the library. The meadow/hill gets a lot of use. There would have been a copse of Oaks and Maples where the monument is now.

#### Flower Beds

The adjacent flower beds are very popular and have a series of rotations of plants during the year. This work is labor intensive and expensive to maintain. Henrietta Yardley, who manages the conservatory and is responsible for the plantings, has asked that we consider something more sustainable with a mix of perennials and annuals versus annuals alone. (Henrietta also suggested placing flower displays at the entryways)

#### Peace Memorial

The paths have been straightened out around the monument to make it more symmetrical. It's been suggested in our focus groups that we bring back Jensen's paths here. It was also requested that the space around the memorial should be more inviting and that we should add more seating and could relate more openly to the meadow and hill. To the west, where Jensen had his larger garden there has been a suggestion to add a children's play area.

#### Stage

The existing temporary stage is of concern to the Park District. It is expensive and time consuming to erect. It has to be insured and when taken down has to be stored off-site. It will soon have to be replaced and therefore the possibility of a permanent platform, integrated into the park design has been suggested. The concept of a band shell was brought up more than once but this conjures up a large facility. The suggestion is for a small platform integrated into the park by grading and planting. The idea of moving the stage to the southwest corner of the park also came up but with mixed reactions.

#### **SW Corner**

What was once the 'Reading Room' came up in every focus group meeting. The mature evergreens, the changes in grade, and the layering of shrubs make it difficult to see into that space. It is sometimes used as a hangout and security concerns here have been raised at all meetings. It has a separate entry which is not often used.





#### Library Plaza

When the library plaza on vacated Grove Avenue was constructed the interaction between park and library was an issue. There is a degree of separation between the park and the library now. Should we integrate the library and park more? Should there be any separation? The configuration of the walls and plaza were discussed in detail.

#### **Tennis Courts**

The courts were also brought up at most meetings and there was debate whether they should remain or be removed. There was a suggested compromise to remove one court in order to create an enlarged space at the northeast corner of the park that is underutilized today.

#### **Ontario Street**

Ontario St., on the north edge of the park, cannot be closed due to the parking and access but as it is one way there is a possibility of bump outs (a traffic calming measure) being added to make crossing the street easier and safer. The sidewalk on the northern edge of the park was removed to allow for diagonal parking but people have created a desire line along the edge of the street. Further desire lines have been formed around the tot lot. The tot lot has been in place since 1987 and is probably due for a rehab. The comfort station adjacent to the tot lot provides some storage and two bathrooms.

Mr. Mac Manus then opened up the meeting to public comment, wishes, and concerns.

#### Public Comment on the Meadow/Hill:

Would you really want to improve the sledding here when there's the hill at Ridgeland? It's more for little kids.

Yes, they are there sledding or rolling down the hill all the time.

I think expanding the meadow would be lovely.

Would you have to take out trees?

There is one tree at the top—it probably wouldn't have to be removed. We would push the path closer to the monument so the flower beds would be taken out or come back in a different form.

The space in the meadow – I would like to see it designated as a U-8 soccer field. The justification is that the business district was asking for the park to bring in more people with activities; they wanted an ice skating rink – I don't want that. But soccer is going to bring in more people to this park on a Saturday morning at 9 than anything and the goal posts could be taken out.

I would be against any athletic activity in this park.

I want to preserve as much green space as possible here.

Keep to the theme of the park being our village green.





#### Public Comment on the Monument:

The memorial is not well set up for memorial services. It would be good to enlarge that area for the purpose of memorials.

I think there could be more space.

I like the idea of a Peace Plaza and I think all of the memorials should be better connected.

#### Public Comment on the Flower Beds by the Monument:

The current beds take a lot of work.

Has there been any thought to using more prairie plants?

Yes, that was discussed even though there were no grasses in this particular Jensen plan. He became well known for using grasses in his later park designs.

Taking out the flower beds and the annuals would make the park less beautiful. If we get rid of the flower beds we would be losing something completely lovely. Maybe we could get more villagers to volunteer and pull weeds.

I love the flower beds. They are one of the best features of the park. They flower from March through October.

#### Public Comment on the 1913 Jensen Plan & Today:

Was all of this (planting) Jensen plan really there?

When I was young this park was like a Garden of Eden. There was a black iron fence that went around it and it was very lush. I think we need to figure a way in which we can maintain Jensen's vision and essence.

The original layout is 20<sup>th</sup> century and we're living in the 21<sup>st</sup> century. There is a more urban environment and a higher density of people around the park today. Soil compaction is always going to be a problem. I don't know if anyone can recall but before we put irrigation into the meadow is was just dirt. The plantings that Jensen used would be beautiful but also costly to maintain and a security concern. In the 1960s the Park District tore out almost every other bush in the parks to increase visibility and safety. I like the idea of changing the paths around the memorial back to the original Jensen layout.

#### Public Comment on the Southwest Corner:

I think the kids like the idea that they're more secluded. They, at times, can be intimidating to others. A lot of the problems are perception and comfort issues. I think if you can bring more people into the park and this area specifically, a lot of the problems are going to go somewhere else. As to how to bring more people into that area – I'm not sure.

I would like it to be more visible at the southwest corner. The trees could be limbed up.





However this corner and the corner at Oak Park Ave. and Lake should have a consistency between them.

#### Public Comment on Security, Teenagers, Homeless:

The edge of the park along Lake St. hasn't presented an issue for the neighborhood beat officer. Teenagers are going to gather where they can gather and they will sit where they can sit. We have this inclination to clear out everything for the sake of visibility but there should be a compromise. I like the idea of engineering a way of bringing more people into Scoville Park.

How do you patrol the park?

The neighborhood beat officer typically starts around the high school when school gets out and then moves to the park afterwards. Most of the complaints will typically be about the area in front of the library.

How many arrests have been made in Scoville Park in the last three years?

The neighborhood beat officer did nott have the numbers in front of him. The numbers aren't overwhelming. Some of the people who cause trouble are arrested elsewhere.

The library plaza generates one of the highest amounts of police calls which are primarily regarding rowdy behavior and noise.

The teenagers do take over that area. They are there when the homeless are not and vice versa. They (the teenagers) can be very rowdy.

The teenagers don't bother me as much as the homeless.

There are PADS sites in Oak Park but the service center is in Maywood.

There isn't a place for them to go and to be engaged so they go to the park and the library.

There is a homeless situation here – could we maybe designate a time to accommodate them in the park?

The public restrooms – there are a lot of problems going on in there. That really needs to be addressed.

I think there are issues in (all) the parks. The presence of the homeless, who can have a lot of addiction issues, and the fact that this park is more centralized, exacerbates it (the issues) here. But, I don't think the park is overrun by drug users.

I am in favor of reinstating the Oak Park Township Outreach Program. A couple of volunteers would go into the park each day and engage the youth in the parks. If we had something like that now it would get youths off of the sidewalk and into the park.

#### Public Comment on the Tot Lot & Play:

I think the Morton Arboretum has done an incredible job getting people involved in nature and play at the same time. The playgrounds interact with the gardens and the observation towers allow you to look into the landscape.





Yes, the Arboretum's playground is wonderful but it's also fenced in and controlled. A very different situation.

The tot lot is very well used. If you add a play area for older children I ask that you keep it separate but maintain visibility between the two.

I second that and I don't think the existing tot lot really needs to be changed.

I agree. I don't think it needs to be updated – it would be expensive.

It will wear out in time. If we do update the playground with new pieces we may not be able to fit in as many pieces due to today's playground safety standards and fall zones. I do think the tot lot needs some updating even if it's just replacing what's already there.

Personally, I would like to see more boulders, like those at Soldier Field, if you want to add a play area for older kids.

#### **Public Comment on Tennis:**

I like the thought of reducing the 3 tennis courts to 2 and making an enlarged space. I think the 3 current courts are a compromise. The surfacing is worn, the nets are often messed up, and the lights are incredibly dim, especially in the middle court. The courts are unusable after 7PM in the evenings.

The tennis courts get a ton of use. I would be opposed to taking one out.

#### **Public Comment on Paths:**

The park is losing all of this usable space in the northeast corner because the entry is further down Oak Park Ave. I would like to see that space get more use.

With A Day in Our Village I think that more pathways would make more room for booths. Presently many booths have to set up inside the paths and the park can become very muddy.

There needs to be a sidewalk on the north side of the park.

#### Public Comment on the Comfort Station:

The restrooms need to be improved.

There are issues of misuse and need for better maintenance.

#### Public Comment on Potential Signage:

I think that the continental divide is very important. I know there's a sign there now but maybe there could be a statue or more signage. It's a big deal that this was once the shoreline and I think more kids should know about it.

People ought to be encouraged to look at the different aspects of history; there's the Hemingway Museum, Unity Temple, and old and new Oak Park. We should try to offer a narrative about us and the evolution of the Village. We should have interpretive signage at the main plazas.





On the Percy Julian statue; the man was very symbolic of our connection to nature. He worked with plants often. I think it would be important to see a larger gesture. This could be part of the park's overall story. The current statue just sits there.

The plaque on the Percy Julian statue is hard to read and doesn't give a lot of information.

I would also like to see the Percy Julian statue expanded. The statue could be in the flower beds among flowers with different colors as a message of diversity or by the children's play area as a message of growth.

The area west of the monument could be a garden with more statues of historical figures.

#### Public Comment on Library Plaza:

The no loitering signs in front of the library have helped.

There are not enough bike racks and they are placed far from the library entrance.

There were many comments on how the plaza is really a go-through space and gets crowded with teenagers.

The library and park could be joined in a better way.

We have to take care not to damage the underground heating system for the concrete as it melts the snow and saves the maintenance staff a lot of work.

It could be a place for a floral display.

It is used as staging area for the events. Trucks pull up there.

#### Public Comment on a Potential Permanent Stage/Platform:

I hope that whatever goes into that stage area does not increase the amount of events or the amount of noise. There are a lot of neighbors in the area.

I live in the Oak Park Club and during concerts I can't use the parts of my condo that face out on to the park because it's so loud.

A permanent stage or a band shell would make it noisier.

I live at Chicago Ave. and the festivals bother me sometimes.

I don't think there should be a band shell. It disrupts the original plan and the meadow and it's only used 7-10 times a year.

We could still get a better portable stage.

A reminder it is a performance platform and not a band shell. This would be a small area.

#### Public Comment on Plaza at Oak Park Ave. & Lake St. (Southeast Corner):

The southeast entry is like an obstacle course.

In Jensen's plan there was no entry there. It was a grove of Plum trees instead.

Mr. Mac Manus asked if anyone would like to see it gone completely – no one raised their hand.

Mr. Mac Manus asked if anyone would like to see it renovated – a majority of people raised their hand.





The fountain is nice when it is working but it gets all that green algae.

(The fountain has not been working for many years and the water that collects is rain water)

I think the plaza could be updated.

The plaza gets a lot of use with people waiting for the bus.

#### Public Comment on South Edge of Park (along Lake St.):

The streetscape is horrendous – the sidewalk is unappealing and not inviting.

There used to be parkway trees along there.

It once was a carriageway.

There is a lot of debris at eye level along Lake St. The fruiting trees mess up the sidewalk and it makes it unattractive.

#### Misc. Public Comment:

This park is not bike friendly and neither is the library. There is a lack of bike racks and the bike racks that are there now are away from the entrances.

Trying to cross Oak Park Ave. at the northeast corner of the park is very dangerous because of the traffic and blocked views. You have to risk your life to cross.

(Cars speed up to get the green light at Lake Street).

Maintenance needs to be addressed in front of the library. There are cigarette butts in the waterfall, they need to power wash the concrete in front more often, and there is a lot of overgrowth where the library meets the park. There are still leaves along Grove Ave. from last fall. It's truly unsightly.

The library is always lit and so brightly too. It endangers the birds and costs a lot of energy. Not a sustainable approach.

The lighting needs to be consistent in and around the park.

As it got close to 9PM Mr. Mac Manus took the final comments and thanked the attendees and encouraged them to attend the next meeting.

Mr. Balling encouraged the attendees to tell other residents and to please come back themselves to the next meeting on Wednesday 21<sup>st</sup> at 7PM. He then thanked all the attendees.

Oak Park residents are invited to attend a community meeting to review a site plan draft recommendation and provide input regarding the current and future use of Scoville Park. Community input is vital to master plan development to ensure the Park District is meeting the current parks and recreation needs of the community, as well as anticipating future needs.

Scoville Park, widely regarded as our "Village Green," was originally designed by noted landscape architect Jens Jensen and was named to the National Register of Historic Places in 2002. Within its nearly four acres lies three tennis courts, a playground and an open field used for summer concerts and special events. In the center of the park is the World War I Monument which is currently being restored. The southeast corner of the park features a replica of a fountain originally designed by sculptor Richard Bock and architect Frank Lloyd Wright. Through a partnership with the Village of Oak Park and the Oak Park Library, Grove Avenue was vacated in 2001 and a new plaza was constructed joining Scoville Park with

the Library.

He welcomed the attendees and introduced Park District Commissioners, members of the Citizens Design Committee and staff that were present. He provided a brief summary of the park planning process thus far noting that Stevenson Park is the last of eighteen parks to go through the process.

The team had already held two focus group meetings and two community meetings and tonight's designs were based on comments collected from these meetings and from the Questionnaire that was posted on the Park District website.

Mr. Balling then introduced the design team and handed the meeting over to John Mac Manus of Altamanu, Inc. Mr. Mac Manus presented a PowerPoint presentation and then requested comments.

#### **Summary of the Presentation**

#### Main Issues

Mr. Mac Manus stated the main points that the team had garnered from the community through comments at meetings, telephone I calls, Emails, neighbors and from staff.

The main issue seems to be that of a perception of a lack of safety. This is created by young people "hanging out" at the front steps to the building and the general lack of sight lines created by changes in level, evergreen plantings and fences.

Security and sight lines are very important and must be addressed.

The main entry is not inviting.

ADA access is very poor and even if you can get up the ramp there are further changes in grade on site and the entry to the building leads to a half landing between floors. In fact the building design is almost contra access and safety.

The field is not used as much as it could be, and there is a very strong call for an All-Weather field but the playground is very important to many residents and park users.

Some residents at the meetings stated that the PD is trying to do too much on a very small site however residents have also suggested batting cages, driving range cage, walks etc.

The Skate Park is very popular but would expanding it be a great return on investment? How many additional residents would it serve?

Neighbors would like to keep entry on SE corner of the park as access from the south is very restricted. They would like this entry made more inviting. This would restrict the use of this space.

#### Overview of previous presentations

Mr. Mac Manus provided a brief overview of previous presentations that will not be repeated here and can be accessed in the minutes from previous meetings.

#### Main Entry along Lake St.

At previous meetings it was decided that the main entry should be redesigned so it is both safer and more welcoming. Many teenagers currently mill around the main entry and sit on the steps as there is a lack of seating. This creates a perception issue and makes the park increasingly unwelcoming. Many schemes were discussed at previous meetings and through the website. The majority of respondents prefer a curved ramp scheme that provides a very gentle change in grade from Lake Street up to the main entryway to the building. The large trees and memorial trees in this area are to be kept. The





retaining wall directly north of the building is to be removed. This new design will provide open sight lines from the building to crossing on Lake Street.

#### **Public Comment**

The entry does look much more inviting but the drawing shows very thick planting still and this could be a further issue in the future. Mr. Mac Manus said that the design team would remove some of the suggested new plantings to ensure safe sight lines.

#### ADA Ramp, Skate Park and Basketball

It was agreed at previous meetings that the ADA ramp would be closed to Lake Street and incorporated into the building uses. It has to stay open however as it is the main ADA access point to the restrooms on the lower floor. If alternate ADA access is provided in the future this ramp could be removed.

Mr. Mac Manus reviewed the various plans for the Skate Park and Basketball. He requested that the community leave the future detailed design of this area to the staff that have to run both and have a greater understanding of the issues. This would provide the attendees time to concentrate on issues concerning the field and the playground. He also stated that at this time it was unlikely that the overall area devoted to either would increase. The attendees agreed with this suggestion.

#### **Public Comment**

Yes it makes sense to leave the design to the staff but what about the shade structures by the skatepark? They should be included so they aren't forgotten.

We will include the shade structures.

#### Dead Zones and the Potential for a new Building

The center provides great views from the second floor to the west and to the east but not to the north and south. This is problematic as it creates 'dead zones' where there are limited sight lines in and out. The evergreen hedge along the west side of the building blocks views from the lower set of center windows and could potentially be removed. The lack of more windows along the south side of the building creates a dead zone as well. The handicap ramp on the east side of the building is narrow to begin with and often used as a viewing platform for basketball games.

Mr. Mac Manus stated that these security issues along with the ADA issues raise the long term need to either rehab the building or replace it completely. However, that is outside of today's discussion. The design team has gone to great lengths to eliminate these dead zones.

#### **Entry from the Southeast Corner**

This entry serves primarily as an access route for maintenance vehicles like pick-ups and tractors. It currently has Grass-crete, a mix of concrete squares with grass planted between to provide support for vehicles, but this may not be the best solution. Mike Grandy, Superintendent of Buildings and Grounds, has planted several new trees along the drive. Park users who use the drive as an entry come from both





the north and south as evident by desire lines. Many requests have been made by residents to keep this entryway open as access to the park is very restricted. Suggestions had been made to expand the skate park into this area but that has now been ruled out. Another attendee had suggested batting cages and another resident suggested a driving range.

#### **Public Comment**

Though batting cages are popular in River Forest only one member of the public liked the idea and it was ruled out. The SE entry will remain but will be improved to provide access for maintenance vehicles and park patrons. There should be a welcoming entry created at the SE corner.

#### Playground

The playground is shown on all proposed plans. The answers to the questionnaire were very informative and the design team has taken note of the suggestions made.

The playground does not need to be separated into two areas. Residents wanted to unite both into the largest playground possible. An undulating surface was interesting but not necessary. People liked many of the existing equipment in particular the train, monkey bars and they would like equipment that increases upper body strength.

A water feature to provide white noise was suggested however, residents felt that it would not be able to compete with the noise of the trains and they would not be able to stop kids from interacting with the water. This raised issues because once the kids interact with the water, the water would have to be cleaned and recycled raising the cost. This was of major concern to the Park District as funds were limited and there are other water features in the area. Mr. Mac Manus then showed a plan showing all the water features in the area including ones just across Austin to the east, Ridgeland to the west, Anderson to the NE and Field to the NW. It was agreed that a water feature was not a necessity and as stated by many in the questionnaire the Park District should spend its limited funds elsewhere.

#### **Public Comment**

Is the playground the same size as today?

No it is a little smaller but it is no longer separated into two and therefore more compact.

It will not have a pathway leading to the fields going through it which will be much better and safer.

The playground should have a fence it makes the parents relax more as they do not have to worry so much about their children.

The playground will have a fence.

We need water, a drinking fountain.

There already is one.

Yes but it does not work well and there is nowhere to wash the children's hands if the Center is closed.

The drinking fountain often does not work because the kids play with it and dump sand into it.

The new playground will not have sand as it causes problems with the fountains and also it can become unsanitary.





Mr. Balling stated that residents of different areas in town felt very differently about sand in the play grounds. Some people loved it others disliked it. However it was an issue for the Park District as it creates problems with rubber surfacing and the drinking fountains.

There was a long discussion about having the restrooms open to the public even when staff was not present. Due to the particular use of the site and the location of the restrooms in the basement this was not a secure solution and raised the issue of a long-term redesign of the Center.

Attendees said shade was important and there should be a grassy area for picnicking.

A resident said that at Field Park the grass near the playground was completely eroded from over use and the same would happen here.

How about a mound?

A mound would take up a lot more space.

Mr. Balling was also concerned with maintenance as mounds have created problems for mowing in other parks.

The design team will try to include a grassy area.

#### **Sports Fields**

Mr. Mac Manus stated that there have been many requests for an all-weather field on this site. It is already lit which is unusual and could therefore get much use. The size of the site is very restrictive but residents had informed the team that a practice field even if it is not very large would get allot of use.

The current grass fields are often out of commission due to inclement weather and a practice all-weather field would provide the kids with a place to practice and save on other fields. Therefore the overall size is important but the largest possible field would be used no matter what.

Attendees had also spoken of a multi-use field, as Lacrosse and other sports could use it for practice as well.

Mr. Mac Manus noted that many designs had been investigated from an Under 10 Soccer Field - 135 ft x 105 ft w/ 10 ft Safety Zone to an Under 12 (Max.) Soccer Field 240 ft x 165 ft w/ 10 ft Safety Zone. This last one would need some regarding along the NE. The construction of a retaining wall running along Lake Street was investigated (he showed a rendering). The cost would be high and impact on the street could be unfortunate. If it was not going to significantly increase the size of a potential field its construction was questionable.

He then presented a series of overall Conceptual Plans

#### Concept A1- Under 10 Soccer Field – 135 ft x 105 ft w/ 10 ft Safety Zone

- Base Ball Back-Stop and Infield to Remain
- The seven (7) Memorial Trees to Remain
- Two (2) Batting Cages (70ft x 14ft x 14ft) & One (1) Driving Range (this option did not receive support)
- New entry at Humphrey (pedestrian and vehicular, approx. 12ft wide)





#### Concept A2- Under 12 (min.) Soccer Field – 210 ft x 135 ft w/ 10 ft Safety Zone

- Same as A1 plan except larger field –Could have all weather surface or grass
- Playground does not decrease

#### Concept B - Under 10 Soccer Field - 180 ft x 135 ft w/ 10 ft Safety Zone

- The main difference is the addition of a Loop Walking Path around the field and the removal of the backstop
- A new staircase and entry on the NW and smooth or gentle ramp down to Lake Street rather than a steep fenced ramp
- · More space for new entry at Humphrey (pedestrian and vehicular) straight scheme

#### Concept C1- Under 12 (Min. Dimensions) Soccer Field – 210 ft x 135 ft w/ 10 ft Safety Zone

- Two (2) Memorial Trees to be relocated
- Base Ball Back-Stop and Infield to Remain
- New entry at Humphrey (pedestrian and vehicular) curved design

#### Concept C2- Under 12 (Max. Dimensions) Soccer Field – 240 ft x 165 ft w/ 10 ft Safety Zone

- Two (2) Memorial Trees to be relocated
- Five (5) Existing Trees to be removed
- Base Ball Back-Stop and Infield to be removed
- New Entry at Humphrey (pedestrian and vehicular) curved design

#### **Public Comment on Fields**

There was little support for Baseball/Soft Ball.

A lighter colored in-field made of all-weather material with a natural outfield was discussed but there was not a lot of support.

If the backstop remains we can't have a proper welcoming entrance on the NW.

The backstop should be moved down by the playground.

This proposal was discussed in detail and eventually after this discussion the attendees agreed that this park should focus on a multiuse field and that the backstop prevents many uses and should be removed. A temporary back stop was discussed but the Park District representative stated that these caused

major storage problems.





Some attendees stated that their children often played softball at Stevenson but they thought they could play elsewhere and that the Park District should install an all-weather multiuse field.

I am in favor of the largest field possible.

This field has lights and therefore would receive a lot of use.

Why do we need a path along the field?

It could be used by senior citizens in the morning, kids jogging during the day or it might encourage more people to watch a game.

This park is still part of the community and should have paths.

We have put paths in most of our parks. Why do we need a path here?

We should focus on the best use here and make the largest field possible.

It could be dangerous for seniors to use the path when there is a game on. Some of the kids can really kick the ball hard and seniors might be injured.

They closed off the track/path at the high school.

Yes but that was not to protect seniors. It was because there was too much use and people were getting injured.

A loop path around the field would be dangerous. The kids would be running on the all-weather surface and then suddenly there would a concrete path.

We could use the wall of the train for practice. If we put in a path this use can't happen.

Mr. Balling stated he was not comfortable encouraging the use of the wall for practice as it is the rail road's property and there could be a security issue.

The paths on the eastern end of the park could be reconfigured to be more like a track.

Yes but we would like a path around the fields and then leading down by a gentle ramp to Lake Street.

You could take out part of the path around the field on the north and east and use Lake Street.

#### After much discussion two options remain:

- 1. A large all-weather field with no path and
- 2. An all-weather field with a path along on the south and west side of a smaller field.

The baseball backstop has been eliminated in both schemes.

A resident suggested marking the path on the east side of the park to make it an official walking path with mile markers.

Both concepts should have lighting.

There was consensus on a new stairs/ entrance on the northwest corner.

For both concepts, include information on trees to be removed and relocated.





#### **Next Meeting**

Mr. Balling stated that there would be another Community Meeting to continue to discuss these issues on Wednesday June  $22^{nd}$ .

Mr. Mac Manus took the final comments and thanked the attendees and encouraged them to attend the next meeting.

Mr. Balling encouraged the attendees to tell other residents and to please come back themselves to the next meeting.

## **Scoville Park Community Meeting #4**

Location: Oak Park Public Library - Veteran's Room

Date: May 25, 2010

Time: 7pm

## **Minutes of Meeting**

Mr. Gary Balling, Executive Director of the Park District, made the introductions to the meeting.

Gary Balling welcomed the attendees and introduced Park District Commissioners, members of the Citizen Committee and staff that were present. He provided a brief summary of the park planning process thus far and noted that Scoville Park is the seventeenth of eighteen parks to go through the process. Mr. Balling added that a great deal of information had been collected from the earlier focus groups, the three prior community meetings, and from subsequent questionnaire feedback. The hope of the fourth meeting was to reach a final plan that would be presented to the Committee of the Whole and Park Board for approval soon after in June. Mr. Balling thanked all of the attendees for participating in the public process and introduced the design team and handed the meeting over to John Mac Manus of Altamanu, Inc. Mr. Mac Manus presented a PowerPoint presentation and requested public comment and feedback along the way.

#### **Summary of the Presentation**

Mr. Mac Manus began with an overview of what would be covered in his presentation. He would provide a quick review of the public process so far, explain the emerging items of consensus, and finally review prior and new design schemes for the park asking for comment and input. Mr. Mac Manus reminded the audience that the purpose of these meetings was to reach an overall master plan, not to work out every detail of design.

Mr. Mac Manus first reviewed Jens Jensen's (a historically renowned landscape architect) philosophy and 1913 plan for Scoville Park. Mr. Mac Manus discussed the challenge of designing the park within this historical framework but still designing for the requirements of modern-day urban society. He elaborated on the addition of the Peace Memorial, which has changed the character of the park and has





become the focal point of the park, and on the difficulty of reestablishing Jensen's planting character without creating public concern for security.

Mr. Mac Manus went over the items of emerging consensus. Some items include: recreating a path along the north edge of the park, adding a fence along Grove and widening the existing walk, expanding the meadow, adding a path along the southern edge of the meadow and incorporating a permanent stage and redesigning the entry at Oak Park & Lake.

#### North Edge of Park Along Ontario & Fence Along Grove

Mr. Mac Manus discussed the current issues at the park's northern edge along Ontario Ave. with a set of before and after illustrations. At Oak Park and Ontario the proposed perspective illustrated new bumpouts, colored crosswalks, a new entry on the corner, and a path along the south side of Ontario. The proposed design's purpose was to slow traffic and make the north side of the park more pedestrian friendly. An additional bumpout was proposed at the corner of Ontario and Grove to reduce crossing distance and increase safety for kids crossing. Mr. Mac Manus reviewed the existing desire lines along Grove Ave. and the proposed fence which would help protect the park and children around the tot lot. The stretch of sidewalk along Grove from the northwest corner to the existing entry into the park would be expanded from 7' to 12' in order to provide more space for pedestrians, bicyclists, and others away from the parked cars.

#### **Public Comment**

Just enforce it as a crosswalk. If the police ticket a few people for not stopping for pedestrians then more drivers will slow at that intersection.

I think the way you've shown it the radius would be much too tight to turn.

o Mr. Mac Manus responded that the perspective was a sketch not a dimensioned drawing and that the radius could be expanded to the correct geometry.

I'd rather see a bumpout at the other end of Ontario where the children cross.

If the northwest corner is going to be a main entry with bikes, strollers, etc. it needs to be bigger than a standard sidewalk.

These recommendations will be reviewed with the VOP Transportation Committee.

#### Southwestern Entry to Park and Library Plaza

Mr. Mac Manus described 'the hangout,' officially known as the outdoor reading room, and stated that security in the SW corner of the park had been raised as an issue in all previous meetings. Many residents showed support for its removal. Mr. Mac Manus described the proposed scheme for a new entry as more open and inviting. Moving on to the topic of the library plaza, Mr. Mac Manus showed the existing plaza's undulating edge and presented a scheme in which it was straightened giving it a more dignified feel. A curb with a low ornamental rail would protect groundcovers planted near the edge. The central portion of the park edge would remain as grass and trees with no low fence, so that tripping of park patrons during special events would not be a concern.





#### **Public Comment**

So you're going to remove the hangout just so the teenagers and users can hang out at the new plaza (Peace Plaza at the Memorial)?

O Mr. Mac Manus replied that there's been a great deal of consensus on this issue in the previous meetings. Part of the current problem is that these trouble areas, the hangout and library plaza, are on a local edge. There are apartments adjacent; it's also the entry to the library in addition to the entrance to the park. The plaza in the middle of the park around the monument would be away from residences, more regional than local, with more people circulating through the area. This area would also be relatively open and well lit with very clear sight lines.

How wide would those paths connecting from the library plaza to the park be?

o Mr. Mac Manus replied that they would probably be 8'-10'.

Could you reuse the existing materials around the library? The limestone is nice.

o Mr. Mac Manus replied that he thought that was a possibility.

I'm going to disagree with the new entry at the southwest corner. I want more mystery when I'm coming into a park. So, for that reason I dislike the open entrance.

However the majority in attendance approved of the new design.

#### Peace Memorial Plaza

The existing space around the monument, Mr. Mac Manus explained, provides no direct access to the monument. Desire lines that would otherwise exist from the Meadow are prevented by the wooden timbers planters and a change in grade. If a new plaza is designed appropriately, the paths could be incorporated into the space in order to increase green space, activate the plaza, and reestablish the more sinuous curves of Jensen's plan. Mr. Mac Manus reviewed the three most liked proposals from the previous meeting and presented an additional scheme. The scheme is based on Lloyd Wright's use of circles in his plans, in particular the Guggenheim Museum in NY. Mr. Mac Manus discussed some of its benefits and compromises but noted that it was still conceptual and needed further work. He then opened up all four schemes for discussion.

#### **Public Comment**

Were the pods in the fourth scheme for chess? It seems like if you remove the pods there'd be more room for the existing mature trees.

o Mr. Mac Manus explained that the pods could incorporate chess or simple seating and that the pods could be massaged or removed to avoid roots of major trees.

We need something to discourage skateboarding.

Would you use a different colored concrete or soft surface within the plaza?

 Mr. Mac Manus responded that Mike Grandy suggested the use of a soft surface material around the monument. Something like decomposed granite would prevent skateboarders from using it.

Would the pods affect the symmetry of the park?





It's a wider area from Oak Park Ave to the monument than from the Grove sidewalk to the monument.

The park is not symmetric.

Which space in your opinion works best?

- Mr. Mac Manus replied that it's a difficult question to answer and that he's really supposed to play the role of moderator.
- o Mrs. Bellalta answered that after Mr. Mac Manus had finished the fourth concept it was the scheme that she thought worked best. The shape accommodates good circulation, it incorporates the better elements from both the circular and oval schemes, and it still allows for some formal beds in front of the monument.

I think someday this park is going to be an international center. The circle is a winner; it has universality with the wonderful synthesis of man and nature.

O Mr. Mac Manus noted that the circle in the fourth scheme is actually slightly stretched making a little bit of an oval. It had to stretch in order to meet the paths but also remain far enough from the mature elm to prevent any damage to it.

I think the monument presents the biggest design issue in the park. Did you look at an option with the memorial off center?

 Mr. Mac Manus replied that the team's design had started off on a much less formal aesthetic, paying more attention to the 1913 Jensen plan, but that over the course of the meetings there had been a shift. Public comment seemed to have driven the parts of the design to a more Victorian and east-coast park styled design.

I question the relationship between a formal plaza around the monument and the rest of the park. It's definitely the biggest design challenge.

I think the fourth scheme addresses some of that asymmetry.

You've also shown the canopy of the trees around the monument which is great because it illustrates some of that randomness of the park.

The monument imposes on the Jensen plan.

The circle is fine with me but I see traffic issues with the narrow walks and corridors. The plan funnels everyone through the plaza and the paths don't look wide enough where they meet the plaza

How big are those paths? How often would the paths be used for festivals?

- o Mrs. Bellalta replied that all of the paths will be increased from 5' to 6' for accessibility and that some could be enlarged depending on the level of traffic.
- Mr. Mac Manus responded that the park is only used for festivals twice a year. A lot of people said that we should not design the park for maximum use events. It is a public park.

In terms of sight lines and passive users of the park, have you considered bench placement?

o Mr. Mac Manus replied that benches would be situated to look onto the meadow and that curved benches could be used around the monument and at the entries.

Mike Grandy noted that the first scheme reduces the pavement behind the monument that he regards as a dead space. He said that putting more hardscape back there doesn't make sense.





Getting rid of desire lines is great but he wasn't sure which of the schemes accomplishes that best. Mr. Grandy disliked the third scheme because of the additional offset paths.

Is there a way to bring more active use to the space behind the monument?

o Mr. Mac Manus commented that Mr. Grandy could be correct; it could be difficult to activate that space.

Where would the Julian bust go?

 Mr. Mac Manus replied that there was a decision to set up a subcommittee that would handle all issues related to memorials and educational signage in order to avoid too much discussion on these topics during the public meetings. "We need to create a framework first and then overlay the memorial layer."

In your experience, could people's behavior readjust to a new form?

 Mr. Mac Manus responded by noting that typically this doesn't have a radical effect on people under 21.

This scheme is not a council ring. The place to put a council ring is in the northeast corner. You could have a real council ring that way.

 Mr. Mac Manus replied that someone at a previous meeting strongly disliked the idea of putting any seating in that corner because it is a local edge with apartments across the street.

I like the fourth scheme and I like the back space because I can see the Julian bust moving there with the possibility to add more busts there. I'm not sure how close you're getting to the tennis courts though.

Lighting can have a strong effect on behavior. Is lighting a big budget item?

 Mr. Mac Manus answered that lighting is another layer to the project. The monument restorer, Mr. Dajnowski, would love to have the monument properly lit and the design team would love to see "up" lighting in the surrounding trees.

I think the fourth scheme is marvelous. I don't like the apron on the north side but otherwise it's great.

 Mr. Mac Manus asked if anyone wanted to speak for any of the other schemes. He also reiterated that the schemes were still conceptual and had details that would be figured out later in the process.

Where would seating be around the monument?

- Mr. Mac Manus replied that curved benches could sit at the edges of each plaza and, in the case of the fourth scheme, around the pods off the main plaza.
- Mr. Mac Manus asked if there was anyone that strongly disagreed with scheme four.
   The audience made no comment.

I'd prefer to see less concrete and sidewalk overall.

What's happening west of the monument?

 Mr. Mac Manus replied that the design recommended was for a space with stones and boulders engraved with information on historic figures that lived and worked in Oak
 Park. Children could be encouraged to search for the stones and to make rubbings of





the engravings as a record of their trip to Scoville Park and Oak Park. Mr. Mac Manus noted that the history and sculpture subcommittee will help work on this.

#### **Tennis Courts**

The meeting moved forward onto the topic of the tennis courts. Mr. Mac Manus explained some of the discussion from previous meetings. The nearest courts in proximity are at the high school, which are not owned by the Park District and unlit. The closest Park District courts are at Taylor Park and at Longfellow Center, each approximately a mile away. The Scoville courts are centralized within the community, lit, and well used during the playing months but some residents feel they have too much of an impact on the park. There have been recommendations to remove either the western most or eastern most court in order to either expand the tot lot or enlarge and activate the northeastern corner. Mr. Mac Manus presented three schemes. The first scheme keeps all three tennis courts, adds a small northern entry on Ontario, and upgrades the tot lot within a more limited footprint (due to the tennis courts and existing tree roots). The second scheme removes the western most court, leaving two, allowing for an expanded tot lot, roll hills, and entry off of Ontario. The third scheme removes a court and relocates the other two to leave slightly more room on both the west and east sides of the park. The tot lot then can be slightly expanded while also having a larger space in the northeast corner of the park. If all three courts are shifted east, as someone had suggested in the previous meeting, they start to move too close to the roots of some mature trees. Because the existing courts are not spaced correctly by today's standards, in each of the scenarios the courts' footprint would have to increase slightly in order to compensate for room between the courts.

#### **Public Comment**

When the vote came up last meeting over whether or not to remove a court it was based on the supposition that we needed more space for the tot lot. I don't think we need to choose between a new tot lot and the removal of one court. All three courts were busy tonight, as they will be for the rest of summer, and I don't see the value of removing one.

If we moved all three courts 10' east there could be enough room for the play area and to retain all 3 courts.

I didn't think the option with the expanded meadow was favored.(NE corner)

There is room for the playground to expand to the south in the scheme with three courts. In comparing schemes one and two, I prefer scheme two (western court removed, leaving two courts with space to expand the tot lot). There's an entry for tennis players and for parents with children going to the playground. All 3 courts are well used but the tot lot is also filled all of the time. Most tennis players can drive or bike to other locations but fathers and mothers with strollers don't have that luxury.

I think the expanded tot lot is lovely but I don't understand why we should have to lose a court. I like the expanded tot lot. The high school tennis courts are only two blocks away.

I can share the concern with the northeast corner because it's a bit of a jungle. If kids want to roll down a hill they can do that on the hill. I think we have to do something with the space in the northeast corner.





Adding the midblock bumpout/drop-off on Ontario for the entry there makes for a potential crossing that is ultimately dangerous. It's a one way street but it's busy with traffic.

 Mrs. Bellalta replied that she had spoken with the Village and Jim Budrick who had given a preliminary okay since it was a one way street and the parallel parking falls within the Park District's property.

There should be a gate on northwest side of the courts for tennis players.

Who are you really dropping off there? You're not dropping off kids of the 2-5 age and tennis players are mainly adults. I don't think you need the drop-off.

- o Mr. Mac Manus commented that it looked as though the drop-off wasn't necessary. In terms of demographics there are more tennis players. The park is surrounded by apartment buildings, it's less of a family neighborhood. If you remove a court, it will never be rebuilt. If you remove or relocate the three smaller trees west of the tot lot there could be more to expand.
- o Mrs. Bellalta responded that it had been considered but that shade was also desired. I wanted to touch on the demographic issue. This park is the community center so the entire demographic of Oak Park should be considered, not just the opinion of those within a couple of blocks.

Many grandparents around the park will have children visiting them and use the tot lot. Tot lots are local theoretically.

Yes, but this is downtown too. Many parents with kids will come shopping and then go to the playground and park afterwards.

The courts at Scoville are lit. The courts at the high school are not.

Is there another option to light or add other Park District courts in Oak Park?

 Mr. Balling replied that he would be reluctant to make a promise like that because he could not guarantee what might result from other master planning processes. Mr. Balling also noted that Oak Park has many lit tennis courts compared to other communities.

But is it enough? If we could we'd make the tot lot huge but we don't have the space. These courts are used all of the time during players' hours.

Mr. Balling commented that he looked at the new entry from Ontario as an important tradeoff and stated that the entry provides an entry to a more open park for tennis players and tot-lot goers.

There is always an interaction between tennis and the tot lot. Many parents will come to the tot lot with their children and play tennis and many children will often sit by the fence and watch the tennis players.

Is the tot lot the same size? How many pieces would we be losing if it was the same size?

- o Mrs. Bellalta replied that given the same size (three tennis courts) the tot lot could fit a similar sized play set as currently on site, a small set of swings, and possibly one or two small free-standing pieces. It would be a tight fit because current playground regulations have larger fall zones and play equipment has to be spaced farther apart.
- Mr. Mac Manus asked the audience to take a vote on whether or not to remove a court.
   9 voted in favor of retaining all three courts and 5 voted in favor of the removal of one court.
   Mr. Mac Manus stated that the tennis courts were not a consensus item.





I know we don't talk about funding but does leaving or removing the tennis court make any difference?

o Mr. Mac Manus replied, not at this stage in the design.

#### Plaza at Oak Park Ave. & Lake St.

Mr. Mac Manus shifted the topic of discussion to the plaza at Oak Park Ave. and Lake St. Residents had asked that it become more welcoming and inviting and less cluttered. However, there have been many requests as to what should remain and be added to the plaza. Some items include; keeping the fountain in its existing location, keeping all of the trees, providing sight lines to the monument, lots of seating, a bus shelter of some type, bike racks, directional and educational signage, a message board or kiosk, and a flower display. A question remains as to whether or not the bus shelter, directional signage, and message board are really issues for the Park District. Mr. Mac Manus presented two main options (one presented previously, one new) for the redesigned plaza, each with or without the fountain remaining, in perspective and plan view. The first option, arcs into the park with an oval planter in the center. The second option, the new scheme, is more curvilinear and with slightly more space. Mr. Mac Manus also presented some diagrams illustrating where a shelter might fit outside the plaza and showed some bus shelter options but noted that the issue did not fall under the Park District's purview.

#### **Public Comment**

I like the first scheme.

The first scheme draws you into the park. You see where you're going.

I like the second scheme with the fountain remaining where it is today.

If you build the case that this was not the historic location of the fountain, I think it can be moved. (back to Lake Street location)

 Mr. Mac Manus noted that the Village will also be adding street trees in grates onto Lake St.

In the first scheme I prefer the fountain raised up but I like the first scheme better than the second.

o Mr. Balling stated that the Park District would need to coordinate with the newspapers on any new newspaper boxes.

There was no consensus on the design.

#### **Trees**

Mr. Mac Manus presented exhibits showing the trees which would need to be removed, relocated, and root pruned. There are six trees in the southwest corner of the park that have to be removed due to the new entry. There is a spruce, already leaning and not in the best shape, just northeast of the monument that would have to be removed for the peace plaza. And there is a pear just northeast of the existing tot lot that would need to be removed in order to expand the tot lot footprint. A plum tree at the NE of the tennis courts has died this year and will be removed.

#### **Public Comment**

Three of the six trees in the southwest corner and the spruce are all memorial trees.





 Mr. Mac Manus replied that the team takes the memorial trees very seriously and works with Nancy Holmes of the Park District Citizen Committee who is in charge of the memorial tree program. Often memorials can be reassigned to other trees or new trees can be planted.

Where is the important oak on the plan?

 Mr. Mac Manus showed the oak, which may be a pre-settlement tree, in the plan and said that the team would be very careful not get too close to it in addition to the 62" elm west of the monument.

The catalpa looks like it is dying and should be replaced.

 Mr. Mac Manus said that the team's arborist will have a look but thought the catalpa could be saved.

Mrs. Bellalta noted that the trees marked with orange are all smaller trees that can be relocated.

Thinking of the elm, would it help if the plaza adjacent to it was a permeable surface?

o Mrs. Bellalta responded noting that permeable systems, whether pavers or a crushed stone, still have significant profiles which can be deep. Permeability isn't so much the issue in that case. One solution is to use a geo-synthetic grid with a membrane on top that is laid on top of the existing soil surface, and raises the grade so that the tree's roots are left with minimum impact.

How many trees do we currently have in the park?

 Mr. Mac Manus replied that he did not have the number on hand but Altamanu will provide the total.

Root pruning is not such a big deal if handled correctly.

There are also anti-desiccants which can be applied to trees in order to stop trauma.

In the sketches you showed the trees next to the library and at the new entry as large with high canopies. Won't they be much smaller going in?

 Mr. Mac Manus replied that in other projects a tight budget requires the use of very small trees. The hope is that larger trees could be transplanted in this instance. It would be nice to plant 6-12" caliper trees there for an instant solution.

I think moving trees that big is questionable.

o Mr. Mac Manus responded that it's important to note that these trees would be grown to be transplanted from a nursery.

What did the arborist say about the mulberry at Oak Park and Lake? You're highlighting a weed tree that is lopsided.

 Mr. Mac Manus replied that it provides an anchor for that corner. When it does go another tree could go there instead.

Mr. Balling closed the meeting as the time neared 9PM and thanked the design team and all of the attendees for participating. The next step in the process is a presentation of the proposed plan and consensus items to the Park Board Committee of the Whole on June 3<sup>rd</sup>. Mr. Balling said that work may continue into July before we get complete consensus. The PowerPoint presentation will be available online and Diane Stanke will send a notice when the final concept is put online.
