Statement

The Park District of Oak Park has a long history of working closely with volunteer non-profit organizations which utilize/support the Park District facilities and/or programming objectives. Both parties benefit from this relationship but the primary reason they exist is because these partnerships benefit our community. It has been observed that the level of interaction/communication by Board members with the Affiliates varies. The role of the Board member will be that of ambassador and all administrative matters will be directed by a member of the staff. The only exception to this would be the representation on the WSSRA Board. For example, some Affiliates are assigned a representative from the Board and Board members regularly attend their meetings/events, while others are invited to an "Affiliates" meeting that is hosted by PD staff on bi-annual basis, while others get no Board attention at all. With the roll out of the new PACT program to redefine relationships between the PDOP and its affiliates, it is a good time to re-evaluate the allocation of Board resources to its affiliates. Relationships are defined through Intergovernmental Agreements, Partner, and Lease Agreements and Affiliate Agreements.

Discussion

With only 5 members, it is not possible for Board members to be present at each monthly meeting of its affiliates. Therefore, it is prudent for the Board to develop a plan that allows us to rotate amongst the affiliates. After much research, thought, and discussion, a new alignment was proposed that would allow the Board to see more of their affiliates. For most of the groups, the presence of a commissioner at their meetings will be a new experience. For a few of the groups, there will be a reduction in Board presence.

Board member #1- WSSRA

Board member #2- Historical Properties/Art- Pleasant Home Foundation/ Historical Society/ Festival Theater/ Art Advisory Committee

Board member #3- Environmental- FOPCON/Greening Advisory Committee/ Memorial Trust Board member #4- PDOP community support organizations- PDCC/ PDOP Foundation/Senior Advisory

Board member #5- Sports Affiliates- Windmills/OPYB/S/Pony/AYSO/Strikers/OPTA/OPRFYF

The idea is that the Commissioners would rotate attending a monthly meeting amongst the organizations, giving priority to those higher in the PACT program and to their annual meetings. They would report back to the Board and staff what they learn at these meetings.
