In reviewing the Parks, Open Spaces and Environmental Features component of the VOP Comprehensive Plan there is some concern regarding what is stated since PDOP is responsible for the public parks and recreation programming in the Village. I stressed this fact at the "Envisioning" meetings that I attended. However, this separation is not clear in the document as presented. I would like to recommend a statement before the vision statement such as:

The Park District of Oak Park consists of 82 acres of open space, 7 community centers, 3 special facilities, 14 Ball Diamonds, 16 Multipurpose Fields, 17 playgrounds, 3 historic properties, 3 natural areas, and in 2012 supported programming for 26,000 participant. The Park District is a separate taxing body and represents approximately 4.9% of the tax levy. The Village of Oak Park and the Park District of Oak Park work cooperatively to improve the quality of life for all Oak Park residents.
