**Intake Narrative Details:**

Tammy Kelley, age 9, came to school with a large abrasion on her right arm. A man walked Tammy to school today. Before leaving he went to the office to explain that he had observed Tammy in a dumpster earlier in the morning. The man refused to give his name saying he did not want to be involved but thought someone should know. When asked, Tammy told the reporter that she was looking for food in the dumpster and fell, which is how she injured her arm. The reporter is also concerned with several smaller injuries on Tammy's arms and hands that appear to be cigarette burns that vary in age. Tammy is rarely to school on time, routinely has poor hygiene, and appears to have a sullen mood. The reporter stated that he is very concerned for Tammy's well being.

**Intake Narrative Details:**

The reporter has not been to the home and does not know for certain if there is food in the home. Tammy has stated that the food in the home is rotten, but she was able to eat some potato chips she found left over.

The reporter does not know if the family has money for food or SNAP benefits.

When asked if anyone brings the family food, Tammy told the reporter that her maternal grandmother used to bring them things including food.

However, Tammy explained that her mother and grandmother got into a fight, and Tammy has not seen her grandmother since before Christmas.

Tammy talked about her grandmother having lots of food at Thanksgiving, and she stated that she wished her mom liked her grandmother more so that they could visit her.
