Sgt. Smith called to request CPS assistance. The police responded to a 911 call requesting an ambulance for an unconscious man, possibly due to alcohol consumption, and with a five year old boy present. Sgt. Smith reported that a second child had been working on a school project with a

classmate near the home, but had arrived home while the police were at the home. The second child is a nine year old girl, who is very emotionally distraught but is being comforted by the neighbor.

The police had taken a statement from the neighbor who called for 911 assistance. Paramedics were preparing to take the man, Louis Collins, to the emergency department for treatment. The neighbor's statement included the following information. While she was out on her daily walk she came across a neighbor's child, Donald, walking along three blocks away from the family's home. The neighbor knows that Donald is in kindergarten and usually gets home around 3:30. Donald had told the neighbor that he wanted to play outside, and that he was not able to wake his dad up. The neighbor had asked Donald why he wasn't with his sister. The neighbor explained that Donald's sister, Sara, is usually seen with Donald. Donald did not know where his sister was, so he just went outside to play. The neighbor is concerned because Donald was playing in the street, had not eaten dinner, and he did not appear to know the way home because he tried to go the wrong direction on two occasions during their walk home. The neighbor explained that when they arrived at Donald's home, she went inside with Donald. Donald's father Louis was laying unconscious on the couch. After shouting several times the neighbor was unable to awaken Louis. The neighbor called 911 to get medical care for Louis because she could not wake him. She observed a large number of empty beer cans laying around him, and she was concerned about potential alcohol poisoning.

Sgt. Smith confirmed that there were several empty beer cans lying around the house. He could not confirm the location of the children's mother, so he is requesting CPS assistance as soon as possible.
