What's New

1. Automatically Clear Arrears flag on receipt of funds


Enhancements have been made to the 'Clear Arrears Flag" process. Currently arrears flags are cleared during the next arrears process &/or when a user clears the arrears flag manually. A new setting is now available to simplify the arrears process and provide a reliable platform to manage arrears notices for lot accounts.

If the new setting 'Clear Arrears Flag' is set in the configuration the arrears flags will be cleared automatically when an owner payment is receipted and the account balance owing is zero or **below** the pre-configured tolerance allowance. This is a global setting and will affect all users.

To utilise the new enhancement, follow the steps below:

1.1 Setting the Arrears flag to clear automatically


- 1. Navigate to 'Receipt Entry'
- 2. Click on 'File'
- 3. Select 'Configure'
- 4. Select the 'Clear Arrears Flags' option
- 5. Tick to activate the setting, as shown below:



1.2 Setting the Clear Arrears Flag Tolerance

Navigate to 'Receipt Entry'

- 2. Select 'File'
- 3. Click on 'Configure'
- 4. Click on 'Clear Arrears Flag Tolerance'
- 5. Enter a maximum Tolerance into the Field



Please Note: 'Clear Arrears Flag' will be defaulted 'ON' for all new clients but will be turned 'OFF' for all existing clients.

Users will need to have security access granted to set/change the 'Clear Arrears Fees' under Security setup 'Receipt Entry Configuration'
