Version 16.5.04 - General Release

Tenant Details	When Tenant Direct Debit was enabled at agency level, a prompt displayed when saving the Tenant Details screen for tenants not configured to pay via Direct Debit. This issue has been resolved.
Outstanding Journals	An issue preventing properties to be archived when there were no outstanding journals has been resolved.
Report Selector screens	When selecting a record in REST Professional report selector screens, the relevant row was not highlighted after typing a character. This has been resolved.
fileSMART Integration	In some instances, the fileSMART integration was not working correctly for databases with a large amount of Regular Payment records. This issue has been resolved.

Asbestos Management (New Feature)

Asbestos Management	The Property Information tab now allows Asbestos Information to be recorded. The following information can be saved:

	An Asbestos Inspection Report is available from Reports > Property > Property Information Reports > Asbestos Report to display asbestos details at property level.
	Asbestos information can be exported and all fields are available to be used as property merge fields.

Other Items

Tenant Direct Debit	A warning prompt will display when saving the Tenant Details screen if a tenant's direct debit amount is less than the tenant's rent amount.
	When generating the Tenant Direct Debit Details report, rent changes will display for tenants with rent negotiation changes, for example: <i>Rent changes 25/06/2018 to \$1,200.00/W</i> .
Outstanding Disbursements	An error when processing outstanding disbursements on databases with large transaction numbers has been resolved.









Trust Receipts	The heading on Sales trust receipts has been changed to <i>Trust Receipt</i> to comply with legislation requirements.
Holiday Bookings	 In some instances, a Holiday Booking was locked after loading the booking in the Holiday Booking Sundry Disbursement screen. This issue has been resolved. An issue with Holiday Booking Credit card details being cleared when launching the Action Diary screen has been resolved.
Gained and Lost Report	The Gained and Lost Report now displays the correct column headers on all pages of the report.
fileSMART Creditor Disbursements	Some drop-down options in the fileSMART Creditor Disbursements screen have been replaced with pop up lists to prevent errors occurring on some installations.
Owner Details	In some instances, an error occurred when archiving an owner with an active property. This issue has been resolved.
Chart of Accounts	The Chart of Accounts report now displays the correct description for all account codes.
Management Revenue Report	 An issue with temporary Holiday Booking creditors being included on the Management Revenue Report has been resolved. Deleted and Inactive Internal Creditors will be ignored when calculating the totals for the Management Revenue Report.
Management Reports	An error when exporting Management Reports from REST Professional has been resolved.
1Form	Changes have been implemented to ensure 1Form applications can be processed correctly when an Automatic User Logout lock is in place.
Outstanding Journals	REST Professional will not allow an Owner or Property with an Outstanding Journal to be Archived.
