#### **Bank Reconciliation** When the system's regional date format was configured with the short data format of dd/mm/yy, modifying Bank Reconciliation Adjustments could result in transaction dates Adjustments not displaying in the adjustments grid. This issue has been resolved. **Tenant Download** When Tenant Download is configured with the bank symbol NABC, transactions with the new code of 399 will be processed successfully and receipts will be allocated based on the information contained in the file. 	<ul> <li>Advertised properties saved in REST Professional with no Open date will now be uploaded correctly via REIWA Web Advertising.</li> </ul>
	<ul> <li>When uploading properties via REIWA Web Advertising, the <i>Full Name</i> field was previously used in the advertisement. A change has been made to use the <i>First Name</i> and <i>Last Name</i> if saved in REST Professional, and only use the Full Name if the First Name and Last Name is not populated.</li> </ul>
Water Usage Invoicing	An issue when using the <i>F12</i> keyboard shortcut to save a Water Usage invoice and opting to allocate Tenant Invoice Credit when prompted has been resolved.
Audit Report	The Chq Date column in the Audit report has been changed to display as Paid Date.
REST Help menu	The Management Spreadsheet Sample has been removed from the REST Help > What's New menu.
Reversing Transactions	When reversing ABA and BPay files, using the <i>Back</i> button will now clear the reference number if already entered, and prompt the user to enter the reference number again to ensure the value is cleared and the correct file is reversed.
