## What's New

# 1. Change committee nominations to be sorted by committee position and allow further sorting within Meeting Hub and Votemax

Committee nominations were previously sorted alphabetically by surname in Meeting Hub and VoteMax. Queensland's latest legislation changes require committee nominations to be sorted by the position, and then by surname.

Changes have been made to Meeting Hub, VoteMax, Offline Voting Register and Document Generation to allow clients to have a choice in how they order committee nominees. Nominees will be sorted primarily by position, and secondly by a choice of surname or lot number.

Within Meeting Hub and VoteMax, the committee nominee's positions will appear in the following order:

- Chairperson
- Secretary
- Treasurer
- Ordinary/Committee Members

A manager has the option to select how they want committee nominees to be further sorted/displayed. The options are:

- By surname
- By lot number
