

1. Marina Sub-group - Levy Notices and Arrears - Email Templates


Levy and Arrears notices in Marina Sub-groups will now utilise the local Levy or Arrears notice email template if one has been set up.

To set up a local email template in the Main or Marina Subgroup, navigate to Levy or Arrears notices / File / Email Template Setup. Use the following steps to add or edit a local template.


- 1. Select Levy Notice or Arrears Notice from the Template Type drop-down list

- 6. A template icon will indicate that there is a local template for the building




Levy Notices emailed from the Main or Marina Sub-group will be emailed using the local template.

Please Note: If no local template is setup, the Global default will be used.




Presentation Financials Style 2 - Arial Professional

- Minor issues have been addressed around Transfer in actions which affected Global Agents and Mortgagees.
- Changes have been made to the transfer in process only the current data for the contact (email addresses and phone numbers) needs to be transferred.
- Enhancements have been made to the DocMax Work Queues to avoid long running work queues causing issues.
- Minor issue has been addressed when running an Unpaid Creditors Report caused by incomplete invoices.
- New Option has been added to. the Web API to provide account balance by invoice code.
- Enhancements have been carried out in EBMax. SCM and MBL no longer require a
 distribute step this is combined with the import procedure therefore the popup
 message 'There are no files to distribute' has now been removed.
- Re-importing MBL data banking for a single building has been enabled though this function should not be required.
- Minor issues have been resolved when running a Business Activity Statement.
 Management Fee postings were failing when post standing journals were initiated were pending fees had previous month dates.
- EFT Manager configuration, 'Amalgamation of payments across buildings' is now obsolete and has been removed from the module.
