# FY 22 Congressional Scorecard

- **FY 2022 President's Budget Request: ~~\$8.86M~~**

- Includes \$50M for DCIP

**\$39.686M**

- **House Appropriations**

- Add \$25M for Defense Community Infrastructure Program
- Add \$25M for Defense Manufacturing Communities Support Program
- Add \$3M for Personnel
- Add \$300M for Public Schools on Military Installations – Davis-Bacon Wages
- Add \$75M for Noise Mitigation Community Partnership (3-yr); rescinds \$50M FY 2021 funds (2-yr) – Helicopter and Tiltrotor Noise Mitigation Study

- Operations & Maintenance: \$15M
- Core Programs of Assistance: **\$25M**

- **Senate Appropriations**

- Add \$20M restoration for OLDCC Defense Wide Review reductions
- Add \$40M for Defense Community Infrastructure Program
- Add \$30M for Defense Manufacturing Communities Support Program
- Rescinds \$45M (\$5M remaining) for Noise Mitigation Community Partnership (avail. until Sep. 30, 2023)

- **Authorization Bills**

- Clarification OLDCC is a field activity, not an OSD component (HASC)

- **Summary:**

- Two bills – HAC is passed; SAC is pending
- House bill does not restore Defense Wide Review reductions
- Anticipation whether conference will restore the Defense Wide Review reductions

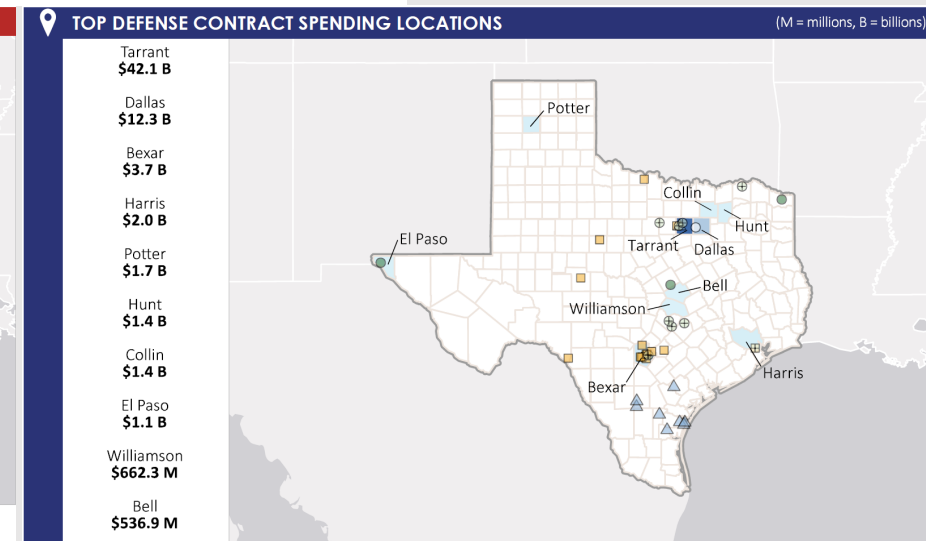
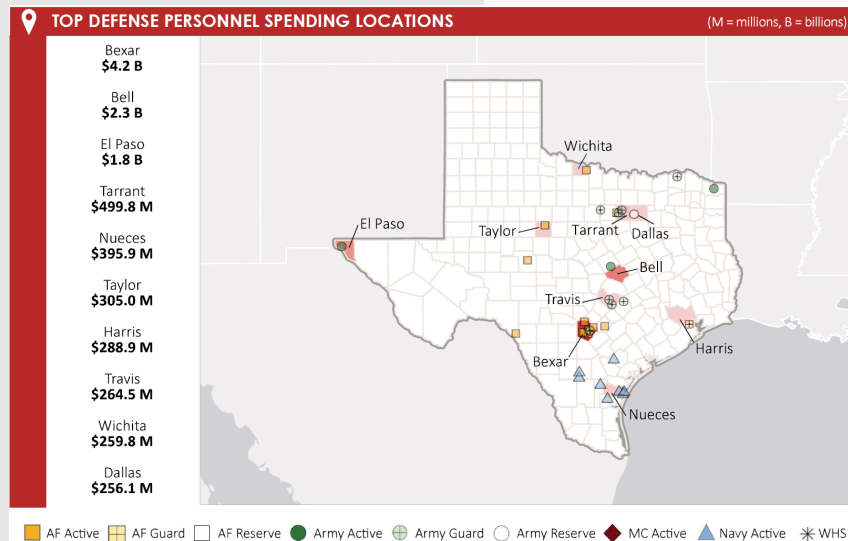

# OLDCC Economic Diversification

- **Community Economic Adjustment Assistance and Economic Diversification**
  - Assistance for States and communities to understand defense dependencies through these defense expenditures and what can be done to make them more resilient for future defense needs
  - We will work with interested communities to determine if one of the following two scenarios applies:
    - 1) Direct military and civilian employment totals at least one and a half times the national level of Defense employment as a percent of the total U.S. labor force (1.95%), or
    - 2) Defense-related expenditures comprise at least one and a half times the Defense percent of gross domestic product (4.8%)
  - A Federal Funding Opportunity (FFO) providing more information about this program activity will be released into the next calendar year

# Defense Community Infrastructure Pilot Program

- **\$60M in FY 2021 - Prioritized enhancements: military value, resilience, and military family quality of life**
  - 90 total proposals received (20 duplicate or ruled non-responsive)
  - 70 complete proposals scored (\$380M DCIP/\$800M Match)
  - 13 proposals selected/awarded (\$60M DCIP/\$68M Match)
- **What worked well**
  - FY 2020 lessons learned and processing enhancements
    - ✓ Webinars, highlight at ADC events, and conducted debriefs to non-selects
    - ✓ Screening, proposal review, and application team approach
  - Generally higher quality proposals resulting in tighter scoring
    - ✓ Provided communities nearly 60 days to prepare proposal
  - The Commander's letter continues to showcase the community cooperation and the need for the enhancement

# Defense Community Infrastructure Pilot Program

- **What worked less well**

- Confusion on military value of the installation vs the value of the enhancement
- Proposals with eligibility/quality/compliance concerns
  - ✓ Other Federal program participation – commitment of funds – shopping \$\$
  - ✓ Location of the enhancement (on/off the installation) – site control
  - ✓ Validity of 3rd party cost estimate
  - ✓ Ability to commence work within 12 months (shovel-ready)
  - ✓ Work which has already commenced (NEPA, Buy American Act issues)
  - ✓ Availability and source of match
  - ✓ Adequacy of back up documentation
- Some high-value enhancements were found ineligible for being on installation leased property

- **Expectations for FY 2022**

- Revisit military value
- Shovel-ready status - DCIP needs to be the last funding needed for a project
- \$50M in FY 2022 President's Budget request; awaiting final Congressional appropriation

# Defense Manufacturing Communities Support Program

- **\$25M in FY 2021: 21 total proposals received (3 ruled non-responsive)**
  - 18 complete proposals scored (\$83.2M DMCSP/\$35.4M Match)
  - 5 proposals selected/awarded (\$25M DMCSP/\$11.7M Match)
- **What worked well**
  - Quality of submissions improved – previous applicants improved the most
  - Tough competition - Very likely would have awarded additional grants if funding had been available, the applications were that good
- **What worked less well**
  - Applicant failure to understand 2 CFR Part 200
    - ✓ Use of federal funds for non-federal match, incorrect determination of contract vs. sub-award
  - Service areas often were too large compared to management capacity of applicant
  - Lack of attention to detail
    - ✓ Local match computation, lack of consistency in use of terms/concepts throughout proposal
- **Expectations for FY 2022**
  - Continue to fine-tune program alignment with OSD Industrial Policy priorities
  - Expand proposal submission pool through expanded outreach and issuing FFO earlier
  - FY 2022 program is subject to final Congressional appropriation

# Military Installation Sustainability

- **Encompasses Compatible Use and Military Installation Resilience**
  - Assistance to State and communities to improve military installation resilience to mitigate impacts from climate and other threats
    - ✓ Utility vulnerabilities, transportation access, wildfire risk/mitigation
  - Installation energy resiliency and overall master plans
- **FY 2021: 21 Compatible Use projects funded worth \$7.9M**
- **FY 2021: 13 Installation Resilience projects funded worth \$8.5M**



# Military Installation Sustainability

- **What worked well**
  - Blending project types
  - Regional Resilience Coordination
- **What worked less well**
  - Coordination and Communication with Services
  - Working with counsel to streamline the legal sufficiency reviews
- **Military Installation Resilience FFO pending publication**
- **Expectations for FY 2022**
  - Federal Funding Opportunity for resiliency (climate)
  - Striving to address natural and human-driven events
  - Growing proportion of core program and funding



# Community Noise Mitigation

- **FY 2021 Appropriations and Report Language - \$50M (2-year funding) to be competitively selected**
- **Fixed wing aircraft - Approximately 205 installations with 65db or greater sound level around a military installation - DOT FAA Part 150 Program coordination**
  - Soliciting Input from Local Officials on Needs Through Federal Register and web portal until Nov. 19, 2021
  - Received 1,724 Survey Responses from 37 Installation locations to date
- **FY 2022 Expectations**
  - House Appropriations Mark for FY 2022: Rescind \$50M, Appropriates \$75M (3-year funding), Rotary aircraft, Congressional Report
  - Senate Appropriations Mark for FY 2022: Rescinds \$45M, leaving \$5M (avail. until Sep. 30, 2023)
  - Program development to proceed into the winter based on feedback and consultations with MILDEPs
  - Catching rotary wing up with fixed wing

# Public Schools on Military Installations

- **Continue Enabling Local Education Agency Responses to Condition and Capacity Deficiencies per the DEPSEC Priority List**
  - Approximately \$2B appropriated through FY 2021 – Invited and working through school #50 (Holloman AFB Middle School) on DEPSEC Priority List – benefiting over 18,000 military-connected children
- **Today Going Forward**
  - House Appropriations Mark for FY 2022: Appropriates \$300M, Davis-Bacon Federal prevailing wages
