### 2. Meeting Hub - Setting Default sorting

Default lists on the following pages are now sorted by Title:

- 1. Standard Agenda Items
- 2. Standard Motions
- 3. Standard Meetings
- 4. Template Groups

When a user defines a sorting preference on all lists where sorting is enabled, the sorting applied by the user will be applied when returning to a page.

**Please Note:** Sorting is specific to a user, machine, page and the specific list on a page (i.e. where a page has three lists on the page, such as the meetings home page, each list can have its own sorting applied) This is in the same manner as the 'items per page' setting in the pagination component.

## What's Better

- A minor issue has been resolved where Motions were being nested under Agenda Items when a meeting is created from a Standard Meeting
- An error was occurring when resolving a custom resolution body, this has now been resolved by ignoring missing fields when determining the resolution body.
- Minor issues have been addressed around formatting Meeting Hub fields. The correct formatting when substituting into Meeting Hub merge fields will now be used.
