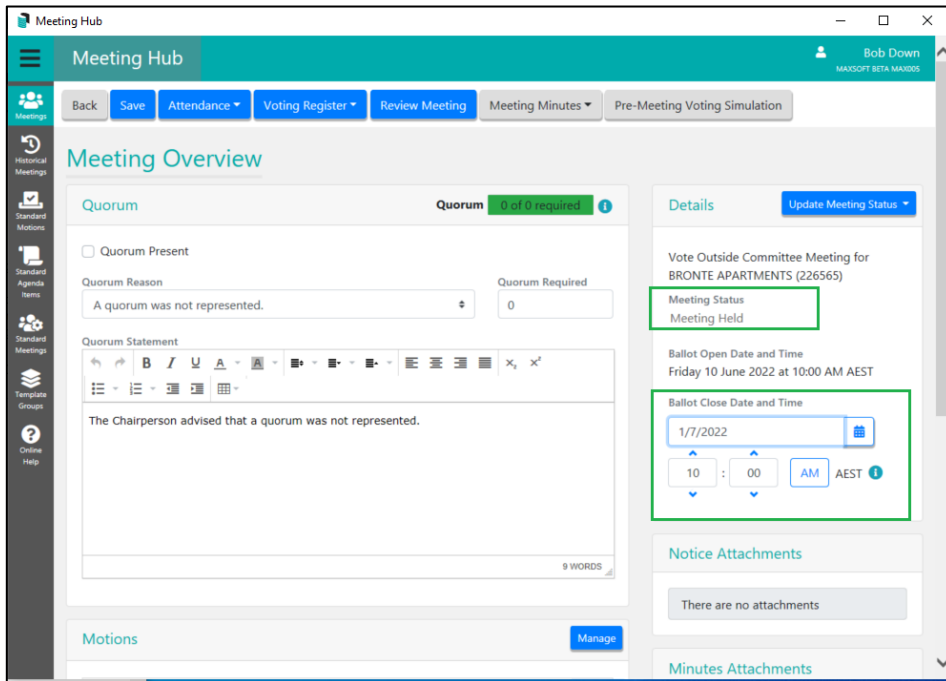
What's New

This release of the Online Voting system introduces new and enhanced functionality to Meeting Hub.

1. Enhancements for ballot only meetings in Meeting Hub

The Ballot Close Date and Time field has been enhanced to reflect the date and time the ballot was finalised if it is finalised before the scheduled date and time.

The Ballot Close Date and Time field can now be updated on the Meeting Overview screen when a meeting has the status of Meeting Held.



The Meeting Date & Time field on the Meetings and Historical Meetings screens is now being populated for ballot only meetings, making it easier to search for a specific meeting.

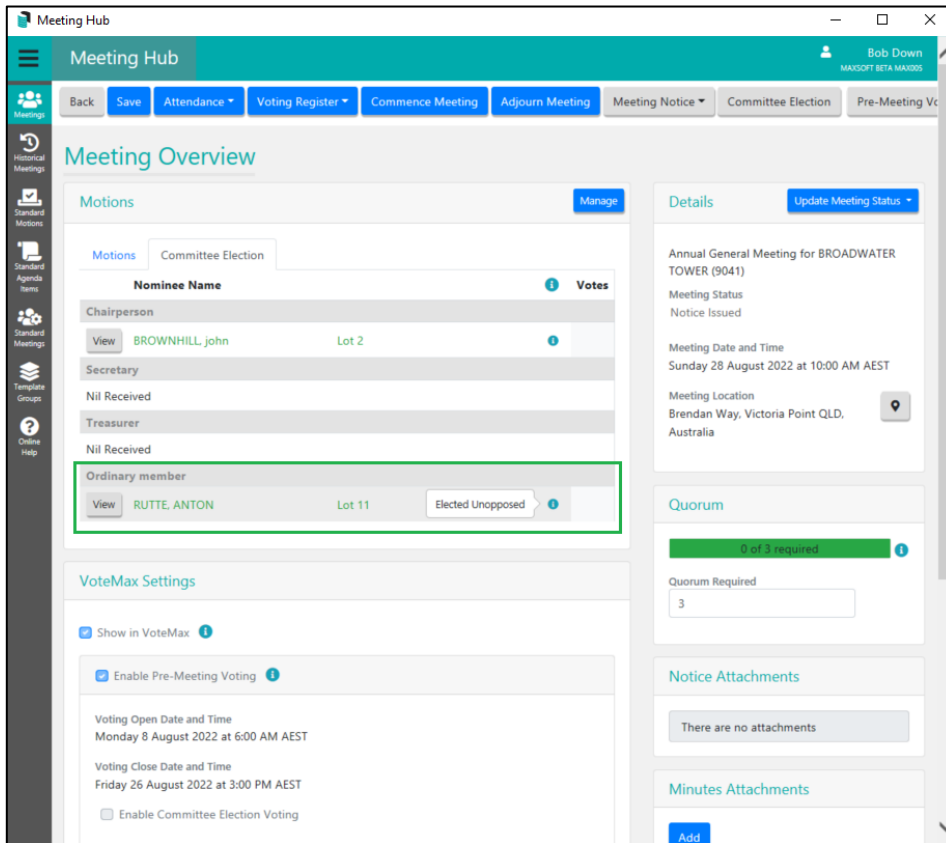

What's Better

- Ballot only meetings have been enhanced to no longer display the Minimum number of Attendees alert when the quorum number is met and the Finalised Meeting option is submitted
- The Body field is now an optional field when creating a Group of same-issue motions (GOSIM), as a standard motion or in a meeting.
- Several errors that were appearing on the Meeting Details, Meeting Overview and In Meeting Management screens have been corrected and are no longer appearing.
- Group of same-issue motions are able to be used in committee meetings in Queensland.
