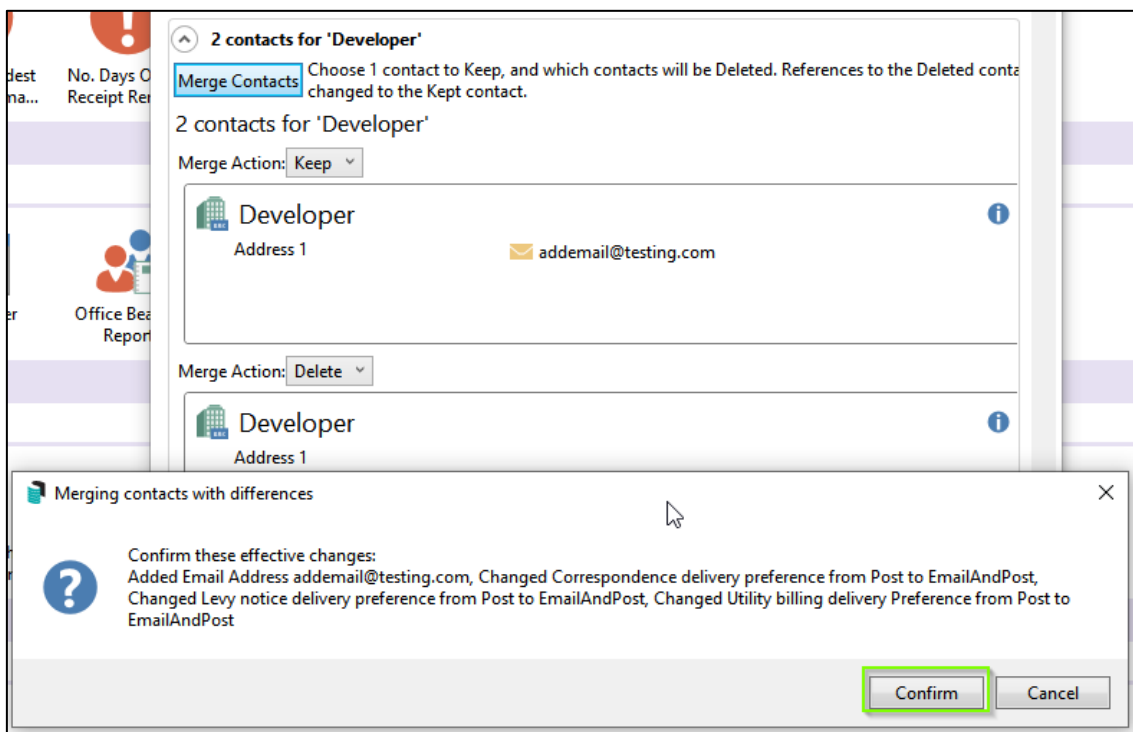

What's New

1. Contact Management – Merge Contacts

We have added a confirmation prompt when merging contacts to allow review of the changes prior to proceeding.

Search or select 'Contact Management – Merge Duplicated contacts, select the contact to be merged and set which is to be kept and deleted. Click 'Confirm' to proceed with the Merge once satisfied that the changes are correct. Any changes made by the merge process will now also be available for review in the Log Viewer.



2. New Building Setup – Add New Lots

When creating a new building with new lots, the date of the roll set up will default to the date of registration for the building. Original Owners will be added as of that date if not modified at the time new lots are created. This will allow the date of acquisition to be backdated if required.

What's Better

- The Building Files description on the Data Health Dashboard has been renamed to Backup Files
- Running the Proposed Budget Report with footnotes to Excel will no longer receive an error
- Roll Change of Ownership - If Reference Name for multiple owners is too long the system was crashing on Change of Ownership. This has now been resolved
- Contacts API - Updated to show the combined details the same as the older rollinfodat data shows
- Roll BuildingId API queries - Move datetimes to dates for some fields that do not need precision for StrataVote
- Process Bank Statements UI was showing unrepresented receipts for the 'current' building subgroup as the value for all buildings in the grid. This has now been resolved
- Deposit Slip – default to the new code and correct Deft version to show credit card by default
- Legislation – Roll Position 'Other Person' is now available for QLD and WA legislation modules
