COVID Vaccines

The following Moderna COVID vaccines have been added to the Vaccine Products Table and VacLogic.

Moderna COVID19 MOD-6-11

- **Vaccine Name:** Moderna COVID19 MOD-6-11
- **Description:** 50 mcg/0.50 mL pediatric primary series for ages 6 yrs to <12 years
- **Inventory Name:** COV2-MOD-6-11
- **CVX:** 221
- **CPT:** 91309

Moderna COVID19 MOD-12-17Y

- **Vaccine Name:** Moderna COVID19 MOD-12-17Y
- **Description:** COVID-19, mRNA, LNP-S, PF, 100 mcg/0.5mL dose or 50 mcg/0.25mL dose
- **Inventory Name:** COV2-MOD-12-17
- **CVX:** 207
- **CPT:** 91301

MONKEYPOX Vaccine

- **Vaccine Name:** MONKEYPOX
- **Description:** Vaccinia, smallpox monkeypox vaccine, live attenuated, preservative free
- **Inventory Name:** MONKEYPOX-JYN
- **CVX:** 206
- **CPT:** 90611

Improved Functionality

Provider [P], Clinical [C], Practice Management [M], Billing [B], All [A]

[B] Columns restored in the Claims window

➤ *Clinical, Practice Management, or Billing tab > Patient Chart button > Claims*

The **Total Patient Paid** and **Total Insurance Paid** columns have been added back to the Claims section of the Patient Chart.

[B] Restored ability to use the spacebar for ICD-10 code search

We've restored the functionality for users to be able to use the spacebar and Enter key while searching for DX codes in the Claims window.

[P, C] Ability to add multiple symptoms per Allergy & Problem.

- *Clinical, Practice Management, or Billing tab > Patient Chart button > Allergies*
- *Clinical, Practice Management, or Billing tab > Patient Chart button > Problem List*

To comply with ONC 21st Century Cures Act regulation standards, users can now enter multiple symptoms per Allergy and Problem as needed. Additionally, each symptom can be further detailed with its own severity.

[A] Ability to disable Curbside

➤ *Admin tab > Global Preferences > Schedule tab*

A new global preference has been added to give Practices the option to disable Curbside in the Add/Edit Appointment window. Once Curbside is disabled, the option will be grayed out for any newly created future appointments.

[B] Option to include PWK segment in Loop 2300 of claims

➤ *Billing > Payers > Insurance Payers List*

Practices can now select the option to **Include PWK segment in Loop 2300 when an E&M code (99212-99215)**

is billed with a **25 modifier** in the Payer Coding Rules when the PWK segment is required on E/M services billed with a -25 modifier.

[C] CPT Codes for Immunization Counseling

➤ *Billing > Procedure Codes > CPT codes table*

The following Immunization Counseling codes have been added to the CPT Code table: G0310-G0315.

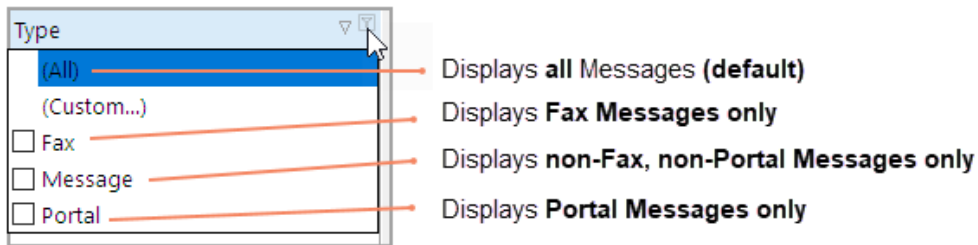
[A] Patient Messages

➤ *Clinical, Practice Management, or Billing tab > Patient Chart button > Messages*

The following enhancements have been made to how Messages are displayed in the Patient Chart:

- An attachment column has been added and is displayed on Messages that contain attachments.
- A Type column has been added to the Message grid so that a patient's Messages can be filtered to display only Fax Messages, only Portal Messages, only Messages that are not Fax or Portal, or a combination of Message Types. By default, all Messages are displayed.

Note: Filters applied to the Message window are saved as a preference if the user chooses to Save Active Form while in the Messages section of the Patient Chart.



[A] Extension field added

➤ *Several*

An extension field (**Ext**)* has been added to the following areas in OP:

- The Day/work phone field in the Basic Information and Family Contacts sections of the Patient Chart
- The Practice Info tab in the Staff Directory
- The Practices and Locations tabs in the Practice/Locations window
- The Work phone field in the Address Book
- The Basic Information tab in the Insurance Payer Details window
- The Message window

In addition, users will receive a warning if:

- They enter a value in the Ext field but leave the day/work phone field empty
- They enter a non-numeric value in the Ext field
- More than 6 digits are entered into any of the Ext fields

[A] Relationship field added to Phone fields

➤ *Clinical, Practice Management, or Billing Tab > Patient Chart button > Basic Info*

A **Relation** field* has been added for each Phone Number in Basic Information so that the relationship to the patient can be specified.

Issue Resolutions

Report Header: Populates the Practice's name and address correctly when printing the Problem List, Allergies and/or Referrals.

Full Patient Search: Users are now able to press Enter on their keyboard to search for patients while in the Full Patient Search window.

Sync Immunizations: Practices that exchange data bi-directionally with their state Immunization Registry no longer receive the following error: 'Error: Message:InsertImmunizationFromRegistry:dxmlmms:Field 'Entering_Facility_code' not found' when importing vaccines.

Change Password Prompt: Newly created users or users whose permissions were recently updated will no longer receive the prompt to change their passwords at each login.

Ability to easily Edit Dx Codes: Users can now edit Dx codes without using the Full Search while in a Patient Chart, Diagnostic Test and/or in the Claims window.
