Weblinks Gender Field Replaced with Birth Sex Main Menu > Clinical Forms Menu > Weblink Inbox - Attach Forms	As part of the release of the new client <u>Standardized Demographic</u> fields, the Client Info section on Weblink Forms now displays the new Birth Sex field with the required options of Male, Female, and Unknown, instead of the legacy Gender field.
21	The new field will be exactly the same as the Birth Sex field found on the Face Sheet, so it will reflect any sub-fields if configured via the Demographics Configuration (Main Menu > Admin Tools Menu > System Setup (Supplemental) > Demographics Configuration).
Exclude Fields from the "Fill From Last" Notes Feature [NoteFillFromPrevForCurrentUser] Main Menu > Various Notes	Agencies with the Fill From Last feature enabled on their Notes will no longer have the Vitals and Appointment Link fields filled in when clicking the Fill From Last button.

Medication Management: DrFirst/eMAR/Medication Plan	
eMAR: Pass Administered On Date/Time Widget Maine Menu > Treatment Planning Menu > eMAR > Med and Treatment Pass	The Pass Administered On drop-down now contains a Date/Time widget instead of having to type the details of the administered pass.

Resolved Issues

IBHRS Agencies

- As per IDPH, LivingArrangmentCode values have been modified and will now be accepted by IBHRS.
- If there are no Services within the Billing Engine tied back to Clinical, the IBRHS Services Export grid will not show any Services and users will no longer get errors.
- Custom-created DSM-5 diagnosis codes created by Agencies will no longer show in exports since IBHRS does not accept them.
- For CDR clients that were not discharged, the IBHRS Export Tool has been updated to include the CDR prefix 'a-#####' in the CareStatusSourceRecordIdentifier column.

eMAR

- Medications are no longer duplicated as view-only when a medication schedule is modified.
- Users can pass medications at any time regardless of timezone differences between local and server time.
- Scheduled Time is displayed as the date the Pass is *due* rather than the start date of the Medication's schedule.
- Users can now access the eMAR application without experiencing an "internal server error".

When the system finds a potential duplicate client, users will now get a Duplicate Client warning rather than an error message.

Currently-discharged clients are now displayed as expected on the Census Billing page if the client was active on the selected date.

Discontinued fields will no longer reappear after clicking the Fill From Last button for Agencies with the Fill From Last feature enabled on their Notes.

Reports and dashboards will no longer be rearranged to the default order after every NextStep release.
