Issue Resolutions

Vaxelis Manufacturer Code: The Manufacturer Code and Description for Vaxelis has been updated for all vaccine inventories, patient vaccines and state immunization registries from 07/07/21 and moving forward.

• Code: MSP / Description: MSP Vaccine Company

For Practices using OP eFax Solution: When an incoming document comes into OP using eFax, intermittently users were not able to view the last page when viewing the eFax document. The eFax file itself did contain all pages and was attached to the patient, but due to the way the document management panel view was working, the last page was being hidden from the view. Now with the fix all pages will be viewable.

Texas: For the file based immunization registry interface, where users upload a file with immunization records to registry, OP has made a change to the interface to capture observation date (OBX-14) as per registry's requirement.

Tennessee: For the file based immunization registry interface where users upload a file with immunization records to the registry, OP has made a change to the interface to capture PAN as the Funding Source for COVID vaccines.
