The following list provides general information on common transaction fees that could be associated with Würk Services. This list is not comprehensive of all costs that could be assessed by Würk. This schedule is provided for informational purposes only and may be changed at any time.

Late Finalization Fee	Fee assessed for any payroll finalized after the cut off timeline.	\$150
NSF or Returned Item Fee	Fee assessed for ACH returned items, including when a payment is fully rejected.	\$5/Prenote Return \$50/Direct Deposit ACH Return \$150/Client Payroll ACH Return 2% percent of NSF (Min \$500/Max \$10,000)
Bank Account Change Fee	Fee assessed for updating customer bank account information.	\$100/account change
FEIN Change	Fee assessed for updating the company FEIN information.	Min \$1,000/FEIN
Tracing Deposits	Fee assessed for researching deposits.	\$100/trace
Re-Print Payroll Checks	Fee assessed for re-printing and re-shipping regularly scheduled live payroll checks (i.e., customer lost package).	\$500/payroll
Wire Transfer Fee	Fee assessed for processing incoming wire transfers. Same-day wire fee for In-and-Out transfers.	\$35/FEIN \$100/In-Out/FEIN
Check Shipment Fees	Check printing trackable shipping fees for: 1.additional locations over 1 per licensed FEIN or 2.customer requested expedited shipment or 3.manual checks - pay statements requested by clients to be printed by Würk and shipped out same day, outside of client's regularly scheduled payroll run live checks *If client provides FedEx Account number to Würk, and all shipments are made utilizing the client's FedEx account number, there is no charge from Würk.	\$28/Payroll Package per Check Shipping Location \$100 Manual Check per Shipping Location
"Applied For" Accounts	Fee assessed for all Tax IDs that remain in an "Applied For" status for more than 30 days in your Würk instance.	\$35 per tax ID per month for tax IDs in "Applied For" status
Stop Payment	Fee assessed for processing stop payments on checks.	\$35/check
Payroll Rollback	Fee assessed for processing a payroll rollback. Please note that rollbacks are only available in certain circumstances. The fee will not be charged if we cannot complete the rollback.	\$200/payroll

Re-Printed W-2 or 1099	Fee assessed for secondary printing and delivery of W-2 or 1099 to customer employee address on file. (Note: Customers can enable Würk platform to allow their employees to elect to have online W-2 or 1099 enabled and automatically be billed for W-2s or 1099s printed and mailed for 2022).	\$5/W-2 \$5/1099
Re-Printed W-2 or 1099 for Former Würk Customer	Fee assessed for secondary printing and delivery of W-2 or 1099 to customer employee address on file.	\$15/W-2 \$15/1099
