


# eMAR Schedule/Review Indicators

Enhancements have been made to eMAR flags when Schedules and Reviews are required. Previously if a Medication or Treatment needed a schedule or needed to be reviewed a single red dot would show next the client's name with no way to differentiate which was needed. Now when a medication or treatment needs a schedule an S will show next to the client's name. When a medication or treatment needs to be reviewed, an R will show next to the Client's name:



We have also added filter checkboxes for each action. You can view just a list of clients that need a medication or treatment scheduled and also view a list of clients that need a medication or treatment reviewed:

Billing - Birth Sex/Gender	If a client has data for both the Birth Sex field and the old Gender field, the software will prioritize the Birth Sex data when sending to NextStep Billing.				
Client Portal - Username Already in Use	An error message will now show when a user attempts to create a portal account with a username that is already in use by another client. The user will need to enter a unique username to complete creating the portal account.				
IBHRS Treatment Validation - Gambling Activity POM Form	The IBHRS Validation tool has been updated to reflect the update made by IBHRS. The validation tool will show an error If a Performance Outcome Measure contains a positive Gambling PreScreening Record, i.e. a PreScreening Record with a Gambling in the Past 12 Months value greater than 4. The Performance Outcome Measure must contain a Screening Result with a Program Area of Gambling.

# IBHRS Validation - Performance Update

Enhancements have been made to cut down the load time of the IBHRS validation. Changes were made to the Search Panel function. The user will now need to select the search button after indicating what they are searching for:

### Resolved Issues

**Billing Configuration - Double Spaces and Tabs:** Copying and pasting tabs, double spaces, and other characters into Billing Configuration was causing the clinical site Billing Box to not function as expected. Now, Billing Configuration automatically trims out unsupported characters.

**Group Deletion:** When a group is deleted in Group Notes that group will also be removed from the scheduler. This will substantially reduce clutter when booking group appointments in the scheduler.

Reminders List Timeout Errors/Performance Issues: We have resolved an issue where the reminders list was occasionally timing out for users upon login. \* This change was reverted in the Clinical 11.2.2 release.\*

**Search Notes with Billing Codes Report**: We've resolved an error on the Search Notes with Billing Code report that was cutting off the clinical information at the top of the report.
