- Validation has been introduced to ensure the required resolutions of same-issue motions created within a group of same-issue motion are consistent with each other. For example, if the resolution of the first same-issue motion is Ordinary Resolution which are used for general meetings, then the resolution types of the remaining same-issue motions must also apply to a general meeting.
- Enhancements have been made to the WYSIWYG editor fields in Meeting Hub to ensure the merge fields are being populated as expected.
- Attendees who are attending the meeting in person can be marked as having left the meeting. Changes have been introduced to ensure votes are unable to be collected for these attendees while they are marked as being away from the meeting.
