TN Ed-Fi Suite 3 v5.3: Student School Associations

Summary

This association represents the School in which a student is enrolled. The semantics of enrollment may differ slightly by state. Non-enrollment relationships between a student and an education organization may be described using the StudentEducationOrganizationAssociation.

Object Triggering

Action	Business Rule(s)
Post	<p>When a new enrollment is saved for a student. A record will report for each distinct enrollment in a School and Enrollment Start Date</p> <ul style="list-style-type: none"> • When a student has two enrollments in the same School, Calendar & Schedule Structure with the same start date, report from the enrollment service type in the following order: <ol style="list-style-type: none"> 1. P: Primary Enrollment 2. S: Partial/Ancillary 3. N: Special Ed Services • When a student has two Primary enrollments in the same school with the same start date, post the record with the highest enrollment ID • When an enrollment with a higher priority is deleted, the enrollment with lower priority will post a new record • Do not send records if the Calendar Exclude check box is checked in the calendar the student is enrolled • Do not send records if the School Exclude check box is checked in the calendar the student is enrolled • Do not send a record if the No Show check box is checked
