Delete /Post	<p>When the Local Course Number is changed</p> <p>If the Term Descriptor changes either via section placement or mapping override and a course offering already exists with non-matching Term Descriptors</p> <p>When there are two Sections with the same natural key and 1 is deleted, the other record will post with the remaining records data</p>
