#### Summary

This entity represents an individual who performs specified activities for any public or private education institution or agency that provides instructional and/or support services to students or staff at the early childhood level through high school completion.

#### Object Triggering Logic

Action	Business Rule(s)
Post	Report a record when a person has a District Employment record that overlaps the configured year with the District Staff check box checked and a District Assignment Code populated and mapped to an Ed-Fi Code <b>OR</b> When a person has a District Assignment record that overlaps the configured year with a Title populated and mapped to an Ed-Fi Code.
	<ul> <li>Do not report a record if the any of the following exclusions are present:</li> <li>There is not a Social Security Number for the staff person.</li> <li>If the record is being triggered from a District Assignment record and it is marked as Exclude</li> <li>If the record is being triggered from a District Assignment record and the School is marked as Exclude</li> <li>If the District Assignment Code / Title field is not mapped in Resource Preferences</li> </ul>
