Summary

The student's special education events

Object Triggering Logic

Action

Business Rule(s)

Post

Reports a record when a student has a SPED State Reporting tab record that overlaps their enrollment and the current configuration year.

- Do not report a record if the any of the following exclusions are present:
 - Enrollment State Exclude
 - Enrollment No Show
 - Enrollment Grade Exclude from State Reporting
 - Calendar Exclude
 - School Exclude
- A Student Special Education Program Associations record must exist for the student prior to sending this resource.
- If there are multiple enrollments, use the following priority list to determine which one should report:
 - Primary > Partial > SPED
 - Earliest Start Date
 - Latest Enrollment ID
- A unique record will post for each SPED State Reporting tab record. If the student has more than one SPED State Reporting tab record, they will send more than one Student Special Education Association Events record.
- A unique record will post for each event entered on the SPED State Reporting tab record.

Delete /Post

A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.

Put

- When the following information changes on a SPED State Reporting tab record:
 - General Information
 - Program Start Date
 - Program End Date
 - SPED Events
 - Babies Can't Wait Notification (01)
 - Parent Consent to Evaluation (02)
 - Initial Evaluation (03)

 - IEP Annual Review (07)
 - Parent Present

 - Special Education Exit (09)
 - Parent Revoked Consent (10)
 - Not Eligible for Initial Provision of Services (11)

- When the following information is changed on the student's Enrollment:
 - Start Date
 - End Date
 - No Show
 - State Exclude

Delete

- When the enrollment being reported off of is deleted.
 When the enrollment is changed to no longer overlap the configured year.
 When the student is excluded through their enrollment, calendar, grade level, or school.
- When the SPED State Reporting tab record being reported off of is deleted.
 When the SPED State Reporting tab record is changed to no longer overlap the configured year.
 When the event date is deleted from the SPED State Reporting tab record.
