Action	Business Rule(s)
Post	<p>When a Student or Staff is eligible to report a Students or Staffs Ed-Fi record.</p> <ul style="list-style-type: none">• If someone is both a Student and a Staff, they will report two records.• To post a People record for student-based logic, the person must meet the posting criteria for Students.• To post a People record for staff-based logic, the person must meet the posting criteria for Staffs.

Delete /Post	A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.
Put	<ul style="list-style-type: none"> • When the following information is changed on Demographics: <ul style="list-style-type: none"> ○ Student State ID ○ Staff State ID • When the following information is changed on Enrollment: <ul style="list-style-type: none"> ○ Enrollment ID (New Enrollment) ○ State Exclude • When the following information is changed on District Employment: <ul style="list-style-type: none"> ○ District Employment ID (New District Employment) ○ District Assignment Code • When the following information is changed on District Assignment: <ul style="list-style-type: none"> ○ District Assignment ID (New District Assignment) ○ Exclude
