## **TN Ed-Fi Suite 3 v5.3: Discipline Actions**

#### Summary

This event entity represents actions taken by an education organization after a disruptive event that is recorded as a discipline incident.

#### Object Triggering

Action	Business Rule(s)
Post	<ul> <li>When a Behavior Resolution is added to an incident that is marked as Complete and is aligned to a reported Behavior Event</li> <li>Do not send if the student is in a calendar marked as Exclude</li> <li>Do not send if the student is in a School marked as Exclude</li> <li>The Resolution must be mapped to an Ed-Fi Value</li> <li>Do not send if the Resolution Start Date is NULL</li> </ul>

Delete/Post	<ul> <li>When data that is part of the Natural Key is changed</li> <li>If the discipline date is changed do a delete and post</li> <li>If the resolution date is changed do a delete and post</li> <li>When the Incident's status is changed</li> <li>Delete when the status is changed from Completed to In Progress</li> <li>Post when the status is changed from In Progress to Completed</li> </ul>

Delete	When a resolution is deleted

	When the student's Role changes to a non-mapped dictionary value
