SIMS Disclaimer (19828)

When logging in to SIMS for the first time, the user will be presented with Terms and Conditions. Once these are accepted, the user will not be prompted again to accept the Terms and Conditions again unless there is an update.

Fixes

SIMSWeb 4 Security Improvements (18516)

Issue: Routine security checks identified some issues in SIMSWeb

Solution: Changes were made to SIMSWeb to satisfy the issues found.

RDS/RDV Forms (18963)

Issue: A user was unable to customize the RDS or RDV forms

Solution: Changes were made to the database with regards to the equipment fields, and a change was made in the code to resolve this issue.

iPocket User Group Security (19063)

Issue: We were told (and unable to reproduce) an issue where Dealer restricted users were able to see another Dealer's information

Solution: We changed the back end to force the Group Code to be passed on account searches, which helps eliminate any confusion.

SIMS Dispatch (19109)

Issue: An issue was discovered where the accountName variable was not working when sending an SMS Message.

Solution: The AccountName variable now works properly. Also, the cross street has been removed from the address display.

Grading Report (Australia) (19585)

Issue: A customer in Australia reported that the Grading Report stopped working.

Solution: The Grading Report has been fixed and tested.

SIMS Pocket iOS 15 (20106)

Issue: iOS 15 will be released this coming fall.

Solution: SIMS Pocket is now iOS 15 compliant.

SIMS III OUS New Entry Issue (21012)

Issue: When using the option for "New Entry" in OUS from an account (from F5), the original OUS entry gets wiped out.

Solution: Changes were made to how the New Entry function worked to fix the issue
