### Appendix

### serviceDuration Calculation

The calculation used is determined by the value selected for the **Service Cycle** field on the *Services Detail* editor. It is recommended that data is entered in the Service Cycle *W: Weekly* format as that is what the state expects. If you receive unexpected reporting results, input the data in a Weekly format.

- If **Service Cycle** is set to value *D: Daily* 
  - Report the **Service Frequency** \* **5** rounded to the nearest whole number.
- If Service Cycle is set to value W: Weekly
  - Report the Service Frequency.
- If **Service Cycle** is set to value *M: Monthly* 
  - Report the **Service Frequency / 4** rounded to the nearest whole number.
- If Service Cycle is set to value S: Semester
  - Report the Service Frequency / (Total Weeks in Calendar Associated to Student's Enrollment / 2) rounded to the nearest whole number.
- If **Service Cycle** is set to value *Y: Yearly* 
  - Report the Service Frequency / Total Weeks in Calendar Associated to Student's Enrollment rounded to the nearest whole number.
