Object Triggering Logic

Action	Business Rule(s)
Post	<p>Reports a record when at least one related person is a student.</p> <ul style="list-style-type: none"> • Do not report a record if the any of the following exclusions are present: <ul style="list-style-type: none"> ○ Relationship Start Date must be on or before 07/01/EndYear. ○ Relationship End Date must be on or after 06/30/StartYear. ○ Enrollment State Exclude ○ Enrollment No Show ○ Enrollment Grade Exclude from State Reporting ○ Calendar Exclude ○ Calendar Summer School ○ School Exclude ○ Private Relationship • If a relationship is started anytime within a school year, the record will be reported for that year. • If the student's is a guardian of themselves (emancipated), then report the student as both the Parent and the Student.
