Post	<p>Report a record when the student has an Early Learning program record that overlaps an Enrollment and the configured year.</p> <ul style="list-style-type: none"><li>• Report a maximum of one record.<ul style="list-style-type: none"><li>◦ If the student has multiple Early learning program records that overlap the enrollment and configured year, use the record with the latest start date. If the same start date, use the record with the highest internal ID.</li></ul></li><li>• Do not report a record if the any of the following exclusions are present:<ul style="list-style-type: none"><li>◦ Enrollment State Exclude</li><li>◦ Enrollment Grade Exclude from State Reporting</li><li>◦ Calendar Exclude</li><li>◦ School Exclude</li></ul></li><li>• "That overlaps an Enrollment and the configured year"<ul style="list-style-type: none"><li>◦ If the student is eligible to report a Student School Association record, they are eligible to report a Student Program Association record.</li></ul></li><li>• For the SPED-related fields, the student must have a locked DE Indicator 12 IEP that overlaps the Early Learning program record (Indicator 12 "Date Completed" must overlap the Early Learning program).<ul style="list-style-type: none"><li>◦ If there are multiple locked DE Indicator 12 IEPs that overlap, the one with the latest Date Completed will be used.</li></ul></li></ul>
