Summary

Holds information on a person's visit to the medical office.

Object Triggering Logic

Action	Business Rule(s)
Post	<p>Report a record when a student or staff has an Office Visit that is marked as "Record Complete" and the Office Visit Date overlaps the current configuration year.</p> <ul style="list-style-type: none"> • STUDENTS - A record is not reported when any of the following exclusions are present: <ul style="list-style-type: none"> ○ Student State ID is NULL ○ Enrollment State Exclude ○ Calendar Exclude ○ Grade Level Exclude ○ School Exclude • STAFFS - A record is not reported when any of the following exclusions are present: <ul style="list-style-type: none"> ○ Staff State ID is NULL ○ District Assignment Exclude ○ School Exclude

<p>Delete /Post</p> <p>Put</p>	<p>A DELETE / POST will be performed if the data element being altered is part of the resource's natural key.
