Post	<p>When a student has a Screening that has a Follow-Up that is within the current configuration year.</p> <ul style="list-style-type: none"> • Do not send a record when one of the following exclusions is present: <ul style="list-style-type: none"> ○ Enrollment State Exclude ○ Calendar Exclude ○ Grade Level Exclude ○ School Exclude ○ Main Screening Type is not mapped to an Ed-Fi Code ○ Follow-up Type is NULL or not mapped to an Ed-Fi Code ○ Follow-up Date is NULL or outside the current configuration year ○ Student State ID is NULL

<p>Delete /Post</p> <p>Put</p>	<p>A DELETE / POST will be performed if the data element being altered is part of the resource's natural key.
