### Overview

#### Summary, Scope, and Purpose

As part of the Consolidated Accountability plan required for the US Every Student Succeeds Act (ESSA), NHED needs to determine students' college and career readiness based upon their achievement on several indicators. The College and Career Readiness (CCR) Submission is a required submission for all districts with a high school (grades 9-12), including charter school districts. A student's college and career readiness is inclusive of their entire high school career. Districts may report a student's attainment of identified CCR indicators that occurred at any point during the student's high school tenure, from grade 9 through grade 12. Students who repeat grade 12 should be reported each year they repeat the grade until they depart school.
