This entity represents a parent or guardian of a student, such as mother, father, or caretaker.

Object Triggering Logic

Post	Reports a record when the Guardian checkbox is checked AND at least one related person is a student.
	 Do not report a record if the any of the following exclusions are present: Relationship Start Date must be on or before 07/01/EndYear Relationship End Date must be on or after 06/30/StartYear Enrollment State Exclude - All related students must be excluded Enrollment No Show - All related students must be excluded Enrollment Grade Exclude from State Reporting - All related students must be excluded Private Relationship The Guardian does NOT need to be a member of the same household as the student. IDOE does NOT provide Ed-Fi IDs to parents. The Parent Ed-Fi ID will be generated as District ID + Person ID if it is NULL when the Parents record is sent. If a relationship is started anytime within a school year, the record will be reported for that year. If the student's is a guardian of themselves (emancipated), then report the student as both the Parent (Contact) and the Student.
