DELETE / POST	A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.
PUT	<ul> <li>When the following information on the student's associated Alternative Education record changes:</li> <li>Begin Date</li> <li>End Date</li> <li>Program Meeting Time</li> <li>Program Eligibility</li> <li>Program Name</li> <li>Reason Exited</li> </ul>
DELETE	<ul> <li>When the Alternative Education record is deleted.</li> <li>When the Alternative Education record Start/End dates are changed to no longer overlap the configured year.</li> <li>When the Alternative Education record no longer has any Program Meeting Times that are mapped to an Ed-Fi Code.</li> <li>When the Alternative Education record no longer has a Program Eligibility mapped to an Ed-Fi Code.</li> <li>When the student no longer has any reportable enrollments in the configured year.</li> </ul>
