Summary

This entity is the final record of a student's performance in their courses at the end of a semester or school year.

Object Triggering Logic

Action Business Rule(s)

Post

Report a record when transcript records are posted for a student in the current configuration year **OR** When the student is in a non-high school course (State Code format is ####.## which is alphanumeric) and is eligible to report a Student Section Association.

- Do not send a record if any of the following exclusions are present:
 - Course is marked as inactive
 - Transcript's score is NULL
 - School Exclude is checked
 - Calendar Exclude is checked
 - Student's Enrollment is State Exclude
 - Student's Enrollment is No Show
- The transcript record can be posted through the Transcript Post tool or through a manual entry.
- If reporting through a non-high school course, reports one Course Transcript record per Student Section Association record that is reporting.
- For a manual transcript entry to post a record without error, all of the below fields must be populated on the transcript:
 - School Year
 - School Number
 - District Number
 - Grade
 - Course Number
 - Course Name
 - State Code
 - Score
 - Unweighted GPA Value
 - Credits Earned
 - Credits Attempted
 - Ed-Fi Term Type (or have a mapped override)
- Important: Indiana DOE has a Tier 2 validation that states you must have a 1:1 relationship between Student Section Association records and Course Transcript records.
 - o If you are reporting 1 Student Section Association for a given student, IDOE expects 1 Course Transcript for that student.
 - o If you are reporting 2 Student Section Associations for a given student, IDOE expects 2 Course Transcripts for that student.
 - ° Etc.

Delete /Post

A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.
