1. Bank Balances/Report- Enhancements

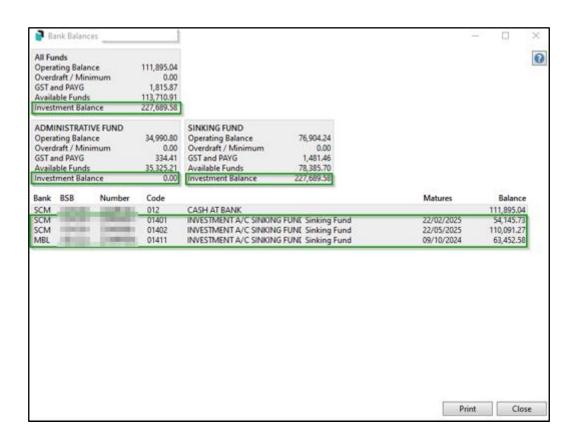
This release introduces several new features and improvements to the 'Bank Balances module and Reporting', Changes include:

- expanded bank account details and investment account visibility
- enhanced reporting and report distribution
- update to the Bank Balance Template

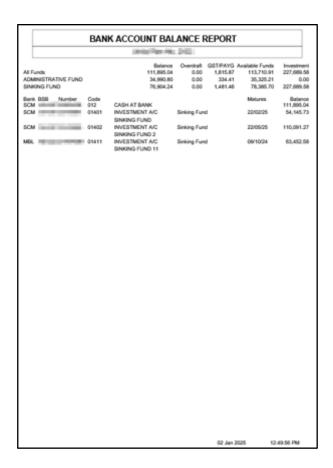
The above changes streamline how users interact with bank balances and reports, providing better data insights and ease of reporting.

To view the changes, please find basic steps below:

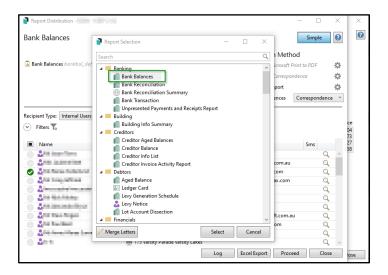
- Navigate to Bank Balances
- 2. Bank Balance display screen will display
- 3. Cash at Bank Accounts, GST and PAYG, Overdraft/Minimum (available Funds) will be itemised out and report as a total Funds Available.
- 4. Investment Account totals will report on the All Funds
- 5. Investment Account Totals will report under the respective funds
- 6. All available Bank Accounts that appear in Bank Account Setup will be listed at the bottom of the report



- 7. Click 'Print'
- 8. Report will appear using Report Distribution module



Please Note – Bank Balances report will now be available to select in Report Distribution as well.

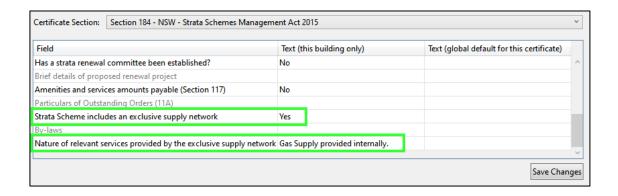


2. Cert 184 - NSW Legislative Change

NSW Legislative changes to be introduced on February 03, 2025, require a new section to be added to Certificate 184 to identify if there is an exclusive supply network established for the building and the nature of the supplied service.

We have added the fields to the Certificate and made provision in Info Editor to include this information on the Certificate. To add data to these fields, use the following steps:

- 1. In a NSW building which uses Cert 184, navigate to Certificates.
- 2. Click Info Editor.
- 3. Scroll to Exclusive Supply Network fields.
- 4. Click into the blank space in the text column beside the field (Note, use the 'This building only' field to add to the current building only and use the 'Global' field if the information is required for all buildings.)
- 5. Add the relevant response.
- 6. Save changes.



The text will be output on the Certificate when produced.

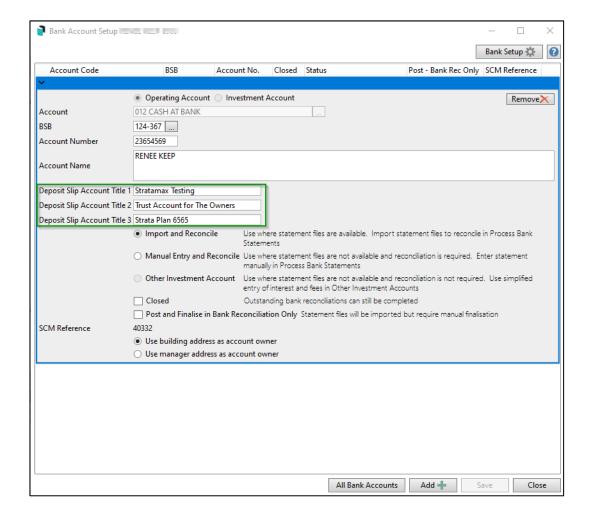

3. Bank Account Setup Changes

Account Title fields will now be available in the Bank Account Setup, these will replace those originally supplied by chapacntdat used for Deposit Slips and Cheques. New Fields in Bank Account Setup are:

- Deposit Slip Account 1
- Deposit Slip Account 2
- Deposit Slip Account 3



Please Note – On update to Version 5.6.122 if the information was available in chapacntdat the new fields will be populated with this information. If not, the information can be manually entered into these new fields.

What's Better

- Management Fees and Recoveries When running Management Fees and Recoveries the Invoices produced were missing the Letterheads. This has now been corrected.
- Funds Management Report Cover Page was reporting the wrong Legislation Number. This has now been updated to the correct number 41.
- Payments when excluding a large volume of creditors system was timing out.
 Query has been adjusted so that SQL Server can process it quicker.
- Levy Register Report Subgroup Entitlements are in separate field on Debtor Record. Owners information - running Owner info and Levy register caused system error. This has now been resolved
- Electricity Bills New Style ABN output is requiring Building to be GST Registered.
 ABN will now appear on Utility bills.
- StrataMax URL Added URL handling for StrataMax application, for better future integration with StrataMax Help
- Report Distribution Multi OC Levy Notices will no longer crash if produced in Report Distribution screens.
- Search Performance Improved performance for searches looking at old year financials/balances (Search Transactions, Search Debtors, Search Building, Search Account
- Journal Prep Tax Code displays as blank and at times saving incorrect tax code.
 This has now been resolved and will clear and re-set the tax code after the list of available tax codes have been changed. This is new validation.
- Change Code When a change code is processed after a building is deregistered the system was returning an imbalance on hidden transactions. This has now been resolved
- Change Transaction Code Old Year Debtor transaction was failing due to missing invoice code.
- Status Reports The following additional reports will now match Status Report period
 - Lot Balance Report
 - Creditors Balance Report
 - Aged Balance List

Account Summary will report current year dates. Transaction list will report current date only.

 Levy Reports - New Style - Arrears/Adjustment and Interest Lines will no longer show in Net Amount in Discount column
