# VT Ed-Fi Suite 3 v7.1: Student School Associations

## Summary

This association represents the School in which a student is enrolled. The semantics of enrollment may differ slightly by state. Non-enrollment relationships between a student and an education organization may be described using the StudentEducationOrganizationAssociation.

## Object Triggering

Action	Business Rule(s)
Post	<p>When a new enrollment is saved for a student. A record will report for each distinct enrollment in a School and Enrollment Start Date</p> <ul style="list-style-type: none"> <li>• When a student has two enrollments in the same School, Calendar &amp; Schedule Structure with the same start date, report from the enrollment service type in the following order:               <ol style="list-style-type: none"> <li>1. P: Primary Enrollment</li> <li>2. S: Partial/Ancillary</li> <li>3. N: Special Ed Services</li> </ol> </li> <li>• When a student has two Primary enrollments in the same school with the same start date, post the record with the highest enrollment ID</li> <li>• When an enrollment with a higher priority is deleted, the enrollment with lower priority will post a new record</li> <li>• Do not send records if the Calendar Exclude check box is checked in the calendar the student is enrolled</li> <li>• Do not send records if the School Exclude check box is checked in the calendar the student is enrolled</li> <li>• Do not send a record if the No Show or State Exclude check box is checked</li> </ul>
