Summary

This event entity represents actions taken by an education organization after a disruptive event that is recorded as a discipline incident.

Post	<p>Reports a record when the Behavior Incident has at least one event with a behavior that is mapped to an Ed-Fi Code AND has at least one reportable student associated to it with the <i>O: Offender</i> role AND is the incident is marked as "Complete" AND the event has at least one resolution with a discipline that is mapped to an Ed-Fi Code AND both the Incident Date and the Resolution End Date overlap the student's enrollment.</p> <ul style="list-style-type: none"> • Behavior-related resources will only report if the associated student is: <ul style="list-style-type: none"> ◦ Participating in Special Education (SPED): <ul style="list-style-type: none"> ▪ Student has a locked IEP that overlaps the date(s) of the reported Behavior Event OR ▪ Student has no locked IEPs AND has a Flag with a State Code of 999 (IEP) that overlaps the date(s) of the reported Behavior Event. ◦ Located in a School that is identified as a 21 CCLC school: <ul style="list-style-type: none"> ▪ The 21st CCLC checkbox is checked on the school's current School History record. <ul style="list-style-type: none"> • School History records that take effect in the future are NOT considered current. ◦ Event is firearms-related: <ul style="list-style-type: none"> ▪ The Behavior Event is mapped to an Ed-Fi Code value of: <ul style="list-style-type: none"> • Handguns • Rifles/shotguns • Multiple firearms • Other firearms • A record is only reported for Enrollments and Behavior Resolutions in the same School Year as the Ed-Fi Connection sending the record. <ul style="list-style-type: none"> ◦ School Year dates are defined in School Year Setup. <ul style="list-style-type: none"> ▪ If Start Date is NULL, 07/01/StartYear will be used. ▪ If End Date is NULL, 06/30/EndYear will be used. • Do not report a record if the any of the following exclusions are present: <ul style="list-style-type: none"> ◦ Enrollment State Exclude - Must be for all students associated with resolution. ◦ Enrollment No Show - Must be for all students associated with resolution. ◦ Enrollment Grade Exclude from State Reporting - Must be for all students associated with resolution. ◦ Calendar Exclude ◦ School Exclude ◦ Role selected is not <i>O: Offender</i>. ◦ The Incident Date or Resolution End Date falls outside of the student's Enrollment dates. <ul style="list-style-type: none"> ▪ We cannot report a Discipline Action record that is outside of the enrollment dates (Tier 2 error -52007). ▪ We cannot send one discipline-related resource without sending the full chain of resources (Tier 2 error -52010). • IMPORTANT: For a Discipline Action to report in AZ, there must be a reportable event, student, and resolution. If any part is missing, a record will not be sent.

Delete /Post	A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.
Put	<ul style="list-style-type: none"> When the following information on the Incident is changed: <ul style="list-style-type: none"> Status (Locked / Unlocked) Changes to Resource Preferences mappings do NOT trigger. A manual resync must be performed on the resource if mappings are changed.
Delete	<ul style="list-style-type: none"> When an incident's status is changed to a value that is not "Completed." When all associated students' enrollments are deleted. When the associated student is no longer identified as Special Education for the time period of the incident. When the associated school is no longer identified as a 21 CCLC school. When the associated event is no longer associated with a firearms-related code. When the incident is deleted. When the associated event is deleted. When the student's Role changes to a value that is not mapped to an Ed-Fi Code. When the resolution is deleted. When the Resolution Start Date is changed to NULL. Error Log

Error Message	Possible Causes / How to Fix
400: Validation of ' RESOURCE ' failed. FIELD is required.	<p>An element of the JSON that is required is missing and needs to be added.</p> <ul style="list-style-type: none"> • Double check that all bolded data elements below are reporting a valid value and no data elements below are reporting an invalid value.
400: ' RESOURCE ' failed. RESOURCE reference could not be resolved.	<p>A resource that was referenced from a difference resource does not yet exist.</p> <ul style="list-style-type: none"> • Resync the resource being mentioned in the error, then resync the errored resource. Alternatively, the resource being referenced may be incorrect. This can happen with Schools and the Ed-Fi School ID being used as an example. Double check the referenced values being sent are valid.
403: Authorization denied. The claim does not have any established relationships with the requested resource.	<p>The key/secret being used does not have permission to send a record for the resource / referenced resource.</p> <ul style="list-style-type: none"> • Double check your API credentials (key/secret). Sometimes specific keys/secrets cannot report specific resources. • The referenced person (student, staff, parent, contact, etc.) has not yet been associated to the key /secret. Resync their "linking" resource (Students Student School Associations, Staffs Staff Education Organization Assignment Associations, etc.) then resync the errored resource. • The referenced person (student, staff, parent, contact, etc.) may not exist in the ODS yet. Resync the "person" resource and the "linking" resource (Students Student School Associations, Staffs Staff Education Organization Assignment Associations, etc.) then resync the errored resource.

404: Failed to delete ' RESOURCE '. Record does not exist.	<p>The attempt to delete a specific Ed-Fi record ID in the ODS failed because it did not exist.</p> <ul style="list-style-type: none"> This error can be ignored. The ID was cleared from the Ed-Fi Identity Mapping Report and will not attempt to delete again.
409: A natural key conflict occurred when attempting to create a new resource ' RESOURCE ' with a duplicate key.	<p>The Ed-Fi API has a natural key system alongside a standard REST ID system. This error is often protecting against the erroneous creation of a duplicate record in the API. However, it may also indicate that the natural key requirements of the Ed-Fi API have not been satisfied, and the key needs to be modified.</p> <ul style="list-style-type: none"> Check for duplicate data in your Campus site. If no duplicate data can be found, report the issue to Campus Support. <ul style="list-style-type: none"> This can be caused by numerous issues. Our code may be attempting to send duplicate records when it should not. The natural key (bolded fields below) may not be unique enough to satisfy Ed-Fi requirements in all cases. Most times this error will require a code change to fix.
409: The resource (or a subordinate entity of the resource) cannot be deleted because it is a dependency of the ' RESOURCE ' entity.	<p>The resource that the application is attempting to delete is referenced from another entity.</p> <ul style="list-style-type: none"> Use the Delete Tool to delete the referenced resource in the error message. Then retry the delete on the original resource that errored.
500: Internal Server Error.	<p>Something unexpected happened and no specific error message could be returned.</p> <ul style="list-style-type: none"> This issue usually occurs when the ODS is having issues. Confirm that there are no issues with the ODS the data is being sent to and then attempt to retry the errored record. Contact Campus Support if 500 errors continue to occur, can be replicated consistently, and the ODS the data is being sent to has no ongoing issues. <ul style="list-style-type: none"> There is a chance that Campus Ed-Fi code is sending an invalid JSON request resulting in the 500 error. There is a chance that an Ed-Fi Data Standard / API bug is causing the issue. Investigation is needed in these cases as there are many different potential causes.
