Post

 - School Year dates are defined in School Year Setup.

This error is often protecting against the erroneous creation of a duplicate record in the API. | | This issue usually occurs when the ODS is having issues. Confirm that there are no issues with the ODS the data is being sent to and then attempt to retry the errored record. Contact Campus Support if 500 errors continue to occur, can be replicated consistently, and the ODS the data is being sent to has no ongoing issues. There is a chance that Campus Ed-Fi code is sending an invalid JSON request resulting in the 500 error. There is a chance that an Ed-Fi Data Standard / API bug is causing the issue.
