Summary

This association indicates the course sections to which a student is assigned

Object Triggering

Action	Business Rule(s)
Post	<p>When a student is scheduled into a course section</p> <ul style="list-style-type: none">• A record will report for each Section record that is reported based on the Sections logic• If roster start date is after the term end date, do not report a record for the prior term• Only send records if the student has a enrollment in the schedule structure where the student is scheduled and is not marked as No Show• Do not send records if the Calendar Exclude check box is checked• Do not send records if the School Exclude check box is checked• Do not send records if the Course is marked as Inactive or Exclude• Course must have a State Code = NOT NULL
Put	<p>When section information is updated for a student or section</p> <ul style="list-style-type: none">• Update when the course or section's homeroom field is changed
Delete /Post	<p>When student's roster start date is changed</p>
Delete	<p>When a student is deleted from a course section</p> <p>Delete any future records if the student is given a roster end date for the course</p> <ul style="list-style-type: none">• Roster End Date must be before Term Start date of future records
