Summary

This event entity represents actions taken by an education organization after a disruptive event that is recorded as a discipline incident.

Post	<p>When a Behavior Resolution is added to an incident that is marked as Complete and is aligned to a reported Behavior Event</p> <ul style="list-style-type: none">• Do not send if the student is in a calendar marked as Exclude• Do not send if the student is in a School marked as Exclude• The Resolution must be mapped to an Ed-Fi Value• Do not send if the Resolution Start Date is NULL
