This association represents the migrant education program(s) that a student participates in or receives services from. The association is an extension of the StudentProgramAssociation with added elements particular to migrant education programs.

#### Post

Reports a record when a Migrant program has a Service Start Date AND the Migrant Program (Services Start Date to Services End Date) overlaps an Enrollment in the configuration year.

  - Enrollment Grade Exclude from State Reporting
     Enrollment State End Status of D1, D2, or D3

  - Calendar Exclude
  - Calendar Summer School
  - School Exclude

- If there are multiple enrollments, use the following priority list to determine which one should report:
  - Primary > Partial > SPED
  - Latest Enrollment ID
