Summary

The studentSection504ProgramAssociations identifies student who both qualify and participate in the Section 504 of the Rehabilitation Act of 1973.

Object Triggering

Action	Business Rule(s)
Post	<p>When a Section 504 record is created</p> <ol style="list-style-type: none"> 1. If Ed-Fi Configuration Profile = Choice + Private Opt In or Choice Only, do not send any records 2. Report from any enrollment determining a record. If the student has multiple qualifying enrollments in the same school, report a record for each unique start date. 3. Do not send a record based on an enrollment that is marked as State Exclude, No Show, or WISE Exclude 4. Do not send a record based on an enrollment is in a calendar marked as State Exclude or Summer School 5. Only send a record from enrollments where State Enrollment Type = Primary 6. Do not send a record for an enrollment in a School marked Exclude or where Entity ID is NULL
