Overview

Summary

North Carolina Department of Motor Vehicles (NC DMV) manages driving licenses for citizens living in the State using the State Automated Driver's License System (SADLS). SADLS is architected using mainframe technology and CICS "green" screens to enter and maintain driver license data. Currently, there is no automated system interface between the Student Information System (SIS) maintained by the Department of Public Instruction (DPI) and SADLS. Reports generated in the SIS contain information necessary to manually enter data into SADLS.

High School Dropout (HSDO) Prevention/Driver's License legislation

North Carolina House Bill 769-GS 20-11 became effective December 1, 1997 and reflects a coordinated statewide effort to motivate and encourage students to complete high school. This legislation requires that a student's driving permit or license be revoked if a student is unable to maintain adequate academic progress or drops out of school.

Lose Control, Lose Your License (LCLL) legislation

North Carolina Senate Bill 57, which became effective July 1, 2000, requires that a student's driving permit or license be revoked for one year if a student is (1) expelled, (2) given a suspension for more than 10 consecutive days or (3) given an assignment to an alternative educational setting for more than 10 consecutive days for one of the following reasons:

1. The possession or sale of an alcoholic beverage or an illegal controlled substance on school property.
2. The possession or use on school property of a weapon or firearm that resulted in disciplinary action under G.S. 115C-391 (d1) or that could have resulted in that disciplinary action if the conduct had occurred in a public school.
3. The physical assault on a teacher, or other school personnel, on school property.

Unlike the "Dropout Prevention/Driver's License" law that only affects students under the age of 18, the "Lose Control" law does not stop at age 18. It is possible for a student to have his or her license suspended as a 17-and-a-half-year-old and not be eligible to drive for a full calendar year, reaching 18-and-a-half before again being eligible to drive.

Due Dates

The SADLS Validation suite is intended to be run on a Semester and Yearly basis.

Scope and Purpose

The SADLS Validation suite reviews student information over the last 365 days. The information provided by these validations are meant to indicate further investigation is needed into a student's driver's permit or license status.
