## Appendix

### serviceDuration Calculation

The calculation used is determined by the value selected for the **Service Cycle** field on the *Services Detail* editor. **It is recommended that data is entered in the Service Cycle W: Weekly format as that is what the state expects. If you receive unexpected reporting results, input the data in a Weekly format.**

- If **Service Cycle** is set to value *D: Daily*
  - Report the **Service Frequency \* 5** rounded to the nearest whole number.
- If **Service Cycle** is set to value *W: Weekly*
  - Report the **Service Frequency**.
- If **Service Cycle** is set to value *M: Monthly*
  - Report the **Service Frequency / 4** rounded to the nearest whole number.
- If **Service Cycle** is set to value *S: Semester*
  - Report the **Service Frequency / (Total Weeks in Calendar Associated to Student's Enrollment / 2)** rounded to the nearest whole number.
- If **Service Cycle** is set to value *Y: Yearly*
  - Report the **Service Frequency / Total Weeks in Calendar Associated to Student's Enrollment** rounded to the nearest whole number.
