Summary

Participating school units shall report all the following to NCDPI by October 15, 2025:

- The number of students offered first priority enrollment in the Program and the total number of students that enrolled in the Program.
- The attendance record of enrolled students.
- Results of the assessments given to students at the beginning and conclusion of the program.
- The number of students who progressed to the next grade level and the number of students who were retained in the same grade level after participating in the program.

The Department of Public Instruction shall report to the Joint Legislative Education Oversight Committee on the implementation of this act and all the information required in this section by January 15, 2026. The report will include:

- Implementation of the School Extension Learning Recovery Program.
- The information required to be reported by participating school units.
- A copy of each Program plan submitted, including any changes recommended by the Department, the reason the change was recommended, and whether the recommendation was followed.
- Any other data or information the Department deems relevant.

Due Dates

Reporting is due October 15th.

Scope and Purpose

The data collected allows users to detect data issues prior to sending their data to the state.

5.3	The student has an enrollment in a Summer School calendar that overlaps their Summer Education program record. This Business Rule does not apply to Extract Type = Helene Recovery Declined Participation.		
5.4	SummerEducation.educationalProgram EQUALS HLP: Helene Learning Program.		
5.5	SummerEducation.parentDeclined EQUALS 1.		
5.6	If a student has more than 1 record that meets the criteria outlined in 5.1 - 5.5, report 1 row of data per unique program record.
