Summary

This association represents the special education program(s) that a student participates in or receives services from. The association is an extension of the StudentProgramAssociation particular for special education programs.

- If the IEP overlaps multiple school years, a new SSEPA record should be created in the 2nd year with the Begin Date (DE60) being the enrollment start date
- If the enrollment sending the record is ended and a new enrollment is added and the same IEP is being used, the student will get a new record with the begin date (DE60) being the enrollment start date
- If multiple IEPs overlap school years, only 1 record is reported with a unique set of primary keys and all fields are populated from the most recent IEP by start date

A new SSEPA record has to be submitted when an IEP is amended:

- Caused by a change on any of the following fields:
 - beginDate (DE60)
 - endDate (DE70)
 - iepBeginDate (DE90)
 - iepEndDate (DE100)
 - specialEducationSettingDescriptor (DE110)
 - wiDpiStudentSpecialEducationProgramAssociationDisabilities (DE120)
- The start date of the new record will be the start date from when the IEP was amended
- Update the wiDpiFapeResponsibleSchoolReference (DE50) if FAPE Responsible field on the enrollment associated with the SSEPA is changed and saved
