Summary

Organization General Information (DN) is a group of reports returning state reported building and district information for the Fiscal Year as represented by the start/end dates selected on the extract editor. The "group of reports" consists of 9 organization types reporting approximately 80 distinct attributes. Each attribute (file) is generated individually each with their own unique reporting population requirements.

- OH Fiscal Year runs from 7/1 to 6/30 of the reporting active year.

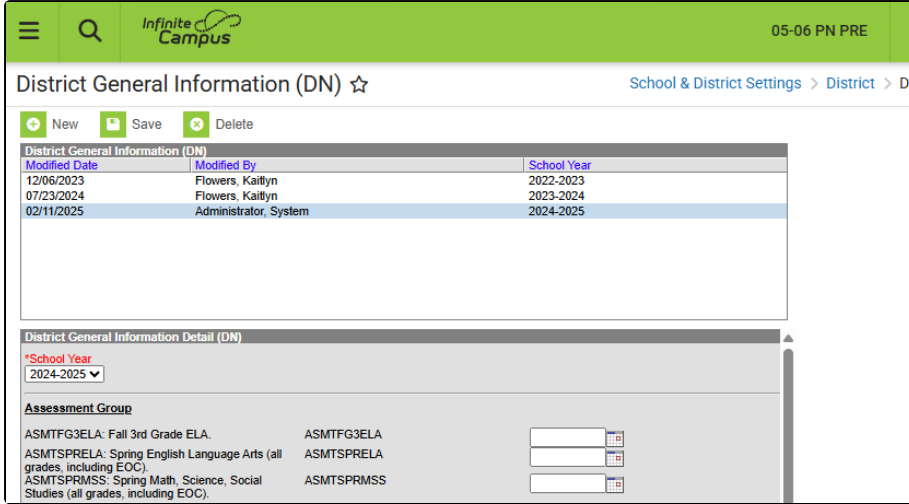
These requirements ONLY apply to the Assessment Group Type/Attributes:

Multiple collection requests for the Assessment (A) Data Set begin in late summer & run through the end of the school year. Generally, a different Assessment (A) Collection Request is made per state test administration. Non-state assessments reported during an Assessment (A) Collection Request in the spring.

Collection in which the Assessment Group is reported: Initial, Midyear, Final, and As of First Day of District Test Window

Attributes in this group are used to report the local assessment window start date if it is later than the state's start date for each listed assessment. Attributes are included in the development of enrollment based missing reports in the assessment collections. Per attribute, the LEA reports the start date of the local window in the Attribute Date field. No reporting is required when a district follows the state assessment window. Each attribute is only reported once for each LEA, with the organization IRN the same as the district IRN on each attribute.

Calendar Group

These requirements **ONLY** apply to the Calendar Group Type/Attributes:

There are two collection requests for the Calendar (C) Data Set. The Initial Calendar (C) Collection Request is open during the spring/summer prior to the beginning of the school year. The Final Calendar (C) Collection Request opens shortly after the initial collection closes and runs through the remainder of the school year. The main purpose of the Calendar (C) Collections is to collect the records that comprise a calendar for each student in order to validate building hours in session and student attendance.

- Attributes report based on **Day Events** entered on the Calendar > Day Editor
- State cross-file validation** exists between the attributes reported in this file **AND** the **Student Standing (FS) attendance calculations**

For Day Events of DBLZZARD, a record reports for each Day with that Event. A separate record reports for each Grade Level that is not marked as State Exclude. If an Attendance Pattern is entered, a record reports for each Attendance Pattern entered for a Grade Level.

For all other attributes, for each Day Event of the reported attribute, each grade level not marked state-exclude reports a record, and within that, a record reports each unique Attendance Pattern.

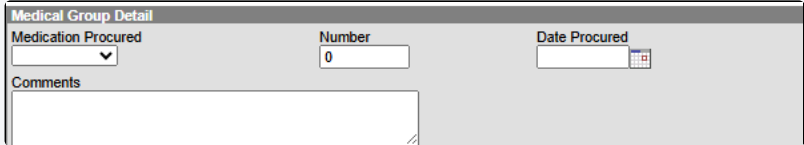
