#### Summary

This association represents the special education program(s) that a student participates in or receives services from. The association is an extension of the StudentProgramAssociation particular for special education programs.

#### Post

When a student has a Special Education Summary record that overlaps the current configured year.

- Only the following Plans are considered for Student Special Education Program Associations:
  - DE Elementary IEP
  - DE Pre-School IEP
  - DE Secondary IEP
  - DE Private School Plan
- Only **ONE** record is posted per unique student, district, and school year combination.
  - This record will reflect the **most current** Special Education information for the student.
    - The most current Special Education Summary has the latest Start Date.
      - In the event of a tie (Same Start Date), the highest internal SPED Summary Record ID will be used.
    - The most current Plan has the latest Start Date.
      - In the event of a tie (Same Start Date), the highest internal Plan ID will be used.
    - The most current Eval has the latest Start Date.
      - In the event of a tie (Same Start Date), the highest internal Eval ID will be used.
    - The most current Meeting Invite has the latest Start Date.
      - In the event of a tie (Same Start Date), the highest internal Meeting ID will be used.
- Do not report a record if the any of the following exclusions are present:
  - Enrollment State Exclude
  - Enrollment Grade Exclude from State Reporting
  - Calendar Exclude
  - School Exclude
